Snure begins with some of the problems he has encountered since arriving back in Portland. - Handwritten letter to Mary Madden and Albert Madden from Dan Snure at Tagish, Yukon. Snure begins by indicating he is working to reach his cabin before the lakes break up. With envelope. 24 Apr 1898.
- Handwritten letter to Mary Madden and Albert Madden from Dan Snure at Hootalinqua, Yukon. Snure begins by indicating he has been very busy since leaving Skagway and that he will be leaving Hootalinqua the following morning. With envelope. 19 Jun 1898.
- Handwritten letter to Mary Madden and Albert Madden from Dan Snure at Hootalinqua, Yukon. Snure begins by indicating he was out in the mountains for about five weeks and found some fairly good prospects but nothing that would pay enough. With envelope. 5 Aug 1898.
