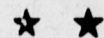

## TEXT OF ADDRESS BY COL. K. B. BUSH AT JUNEAU ON PRESENTATION BULKLEY'S JOURNAL TO MUSEUM.

Governor Gruening, Secretary Bartlett, Mr. Keithahn, my friends of Juneau: We of the Northwest Service Command have been favored with so many kindnesses by the people of Alaska in general and you of Juneau in particular that it is a pleasant duty for us to come here today on behalf of the Commanding General of the Northwest Service Command to present the Bulkley Telegraph Trail Journal to your Territorial Museum and to the chief executive of Alaska.

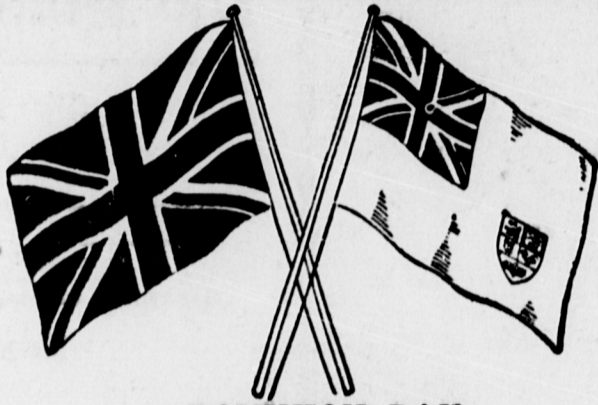
And in making this presentation I like to think that Colonel Bulkley and his heroic followers would consider it especially appropriate. Much of their adventurous exploration took place in the lofty and imposing mountains which guard this community. Their wilderness trek led them both up the Inside Passage by naval craft and through the Coastal Range on foot. And their charting of the far-flung fastnesses of Russian-America, as Alaska then was called, resulted directly in 1867 in the purchase of this vast land from the Imperial Russian Government by Secretary of State William H. Seward for \$7,200,000. In fact, the map folded in the back of the Journal that I bring today is a photostatic copy of Colonel Bulkley's map which lay on Secretary Seward's desk when he completed that historic and momentous transaction three quarters of a century ago.

So it is highly fitting that a copy of the frontier Colonel's Journal and Letters should come at last to the capital of the Territory which he was so influential in adding to the domain of the United States.

In recent months we have had the honor to present copies of this document to many distinguished persons. At Ottawa in February Brigadier General James A. O'Connor, commanding general of the Northwest Service Command, presented one to the Canadian Government's archives through the Right Honorable W. L. Mackenzie King, Prime Minister of the Dominion. On that occasion—an occasion which will ever be remembered by those of us privileged to participate—General O'Connor declared.

"I have brought with me another token of Canadian-American friendship. Nearly eight decades ago far-sighted men in our lands dreamed of a route northwestward across our continent toward Asia. This was the Telegraph Trail an expedition which was to string telegraph wires through British Columbia, through Alaska, and into Siberia and Eur-

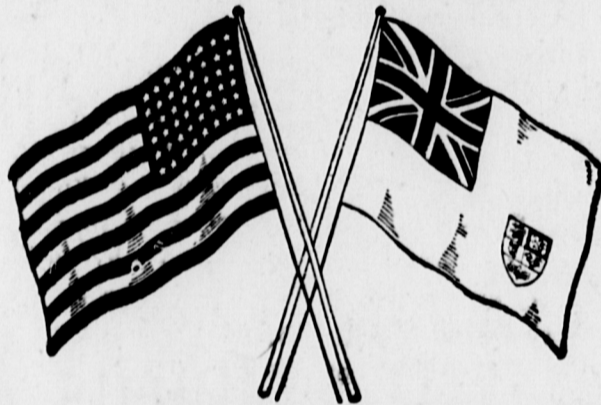

We on this continent have much in common. Our problems are in various ways very similar. Our democratic outlook on life is such as to be almost indistinguishable between the two peoples. The unfortified boundary across the whole continent separating the two countries has been the finest object lesson the world has ever known demonstrating how two nations can live and work in peace and comfort side by side and to their mutual advantage. The construction and completion of the Alaska Military Highway is another link now being forged which will hereafter serve to strengthen the ties of mutual understanding and good fellowship already existent and which it has been the blessing and privilege of us all to enjoy.

Today we have a common enemy to defeat and subdue both in Europe and the Orient. Unitedly we are now fighting side by side to accomplish this objective. This again will tend to further strengthen the bonds of kinship which together we have fostered and developed throughout the years.

### "A HAPPY BIRTHDAY TO YOU"

#### MR. AND MRS. FRANK WILSON LEAVE FOR THE COAST AND WILL MAKE THEIR FUTURE HOME IN VANCOUVER

Mr. and Mrs. Frank G. Wilson left Wednesday morning for the coast and will make their future home with their son, Frank, at 7658 Hudson Street, Vancouver.

They arrived in Whitehorse in 1902 and, excepting for a few years spent in Dawson, have resided here since that time. During their long residence in Whitehorse both have taken an active interest in the social welfare of this community. For a number of years past they very gen-

erously arranged for the regular monthly meetings of the Whitehorse Chapter, I.O.D.E. to be held at their home. In various other ways they have always been ready and willing to do their part in community work when called upon to do so. Their many friends much regret that, due to ill health, they have found it necessary to return to the coast where it is sincerely hoped both will spend the remainder of their days happily among their loved ones.

## W. M. NEAL VICE-PRESIDENT C. P. R. AND PARTY ARRIVE IN TOWN.

In a company plane piloted by Mr. Grant McConachie, general manager of western lines, Mr. W. M. Neal, vice-president of the C. P. R. and Canadian Pacific Air Lines Ltd. arrived in town Wednesday night on an official trip through the north. He was accompanied by Hon. F. P. Brais, K. C., Montreal, government leader in the Quebec Upper House, W. A. Mather, vice-president C. P. R. at Winnipeg, F. W. Ross, assistant general manager, Bank of Nova Scotia, Winnipeg, and H. E. Sellers, president of the Federal Grain Co. Ltd. They are making a 7,500 mile trip by rail, air and motor over the areas served by the Canadian Pacific Air Lines. When in Edmonton Mr. Neal stated that quite apart from the Alaska Military Highway recent revelations concerning the Fort Norman oil wells and construction of a pipeline to transport this vital fluid to the Alaska Highway and to military and naval basis elsewhere in the far north indicate that the whole field of natural resources in the north is under intensive exploitation which cannot fail to be of economic value to Canada. Commenting on the post-war tourist traffic over the Alaska Military Highway Mr. Neal stated that he anticipated a steady but gradual development of air-borne tourist traffic to the beauty spots and hunting grounds of the northland as well as to the great mining centres now being developed. At present, however, no plans had been made for the development of this traffic nor for the erection of accommodation to handle this expected tourist influx. These were matters for discussion in the post-war period when the question of who will develop this traffic will be discussed and determined.

Mr. Neal and his party left by plane yesterday morning for Fairbanks and possibly Nome. Mr. H. Wheeler, chairman of directors of the W. P. & Y. R. who has personally known Mr. Neal for the past twenty years accompanied the party on the trip.

## INDIANS AT MOOSEHIDE INOCULATED AGAINST TYPHOID FEVER.

Because of a possible typhoid epidemic at Moosehide, an Indian village near Dawson, it is reported that more than 500 persons have been inoculated. Dr. A. C. Duncan, medical health officer for the district, has ordered compulsory inoculation of all Indians. At present it is stated that seven Indians are in quarantine.

## BRITAIN AND BUREAUCRACY

The broad mass of these (British) Islanders are firmly determined to get rid of restriction and compulsion at the earliest possible moment after the war. Any politician who fails to notice this will get into an appalling amount of trouble. Oddly enough, although nothing is more striking than this national determination to see the greatest possible measure of individual liberty restored at the earliest possible moment after the war, yet a growing number of political leaders of all parties have failed to see it—especially so those of the left . . .

"One politician after another commits himself to post-war schemes involving bureaucratic management of the individual from birth to death. The Leftists are more totalitarian than anyone else, though there are not a few among members of the Conservative Party. That any politician with even a meagre knowledge of British history can seriously believe that this highly independent nation will capitulate to bureaucracy is incredible—a people which has pulled down and destroyed every repository of power which has dared to manifest itself during a thousand years, which has faced and overcome every form of tyranny upon which it could lay hands, will never give itself over to control by an executive decreeing when and where one shall be born, in what subjects one shall be educated, the kind of work one shall do, the measure of one's amusements, the size of the house one may build, the day upon which one must finally cease work, and the type of State coffin into which one will be placed at the last . . .

## A. C. BLANCHARD FOR MANY YEARS GENERAL AUDITOR W. P. & Y. R. DIES IN SKAGWAY.

SKAGWAY, Alaska.—A. C. Blanchard, pioneer of Skagway and for many years General Auditor of the White Pass and Yukon Route, passed away at his home here recently. He is survived by his wife and three sons.

Mr. Blanchard was born in Glasgow, Scotland, about 64 years ago. With his family he came to this country as a small child and settled in Washington Territory. In 1900 he went to Skagway. Thirty-two years ago he was married to Olive Springstead, daughter of Mrs. P. S. Ganty.

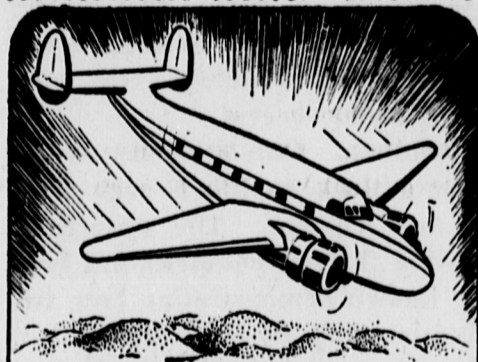
Active in the civic affairs of Skagway, a past exalted ruler of the Elks Lodge, Mr. Blanchard was one of the town's foremost citizens. Known for his excellent voice, he sang in opera in the States as a young man.

Two brothers, William Blanchard, a former executive of the White Pass Company and now retired and living in Washington State, and George Blanchard, whose home is in Port Orchard, survive.

Three sons of the family are Alex, Jr., of Warren, Wash., and Gordon and Douglas, both in the Army in Alaska. Douglas Blanchard recently entered the service and is at Duck Creek. He plans to go to Skagway on the first available transportation. Three grandchildren, sons of Alex Blanchard, Jr., also survive.

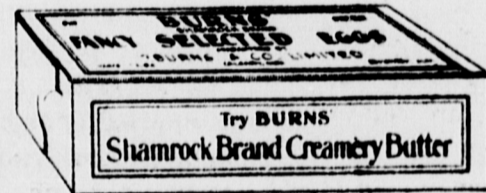

## Synopsis of Mining Law Yukon Territory

Any person eighteen years of age or over shall have the right to enter, locate, prospect and mine upon any lands in the Yukon Territory, whether vested in the Crown or otherwise, for the minerals defined in the Yukon Quartz Mining Act and the Yukon Placer Mining Act, with certain reservations set out in the said Acts.

No person shall enter for mining purposes or shall mine upon lands owned or lawfully occupied by another until adequate security has been furnished to the satisfaction of the Mining Recorder for any loss or damage which may be thereby caused.

Where claims are being located which are situated more than one hundred miles from the Mining Recorder's office, the locators, not less than five in number, are authorized to meet and appoint one of their number as emergency recorder, who shall as soon as possible deliver the application and fees received to the Mining Recorder for the District.

If two or more persons own a claim, each such person shall contribute proportionately to his interest to the work required to be done thereon, and when proven to the Gold Commissioner that he has not done so his interest may be vested in the other co-owners.

The survey of a claim made by a duly qualified Dominion Land Surveyor shall be accepted as defining absolutely the boundaries of the claim surveyed, provided the survey is approved by the proper authority and remains unopposed during the period of advertisement.

A person about to undertake a bona fide prospecting trip may secure from the Mining Recorder written permission to record at his own risk a claim within six months.

A legal post must stand four feet above the ground, squared or faced for the upper eighteen inches and measuring four inches across the faced portion. The post must be firmly fixed in the ground.

Priority of location shall be deemed to convey priority of right. Certain disputes may be heard and determined by a Board of Arbitrators.

Grants of claims grouped or owned by one person may be made renewable on the same date.

### PLACER MINING

Creeks means any natural water course having an average width of less than one hundred and fifty feet between its banks.

Creek claims shall not exceed five hundred feet in length, measured along the base line by one thousand

feet on each side of the base line. Other claims shall not exceed five hundred feet in length by one thousand feet in depth. Claims shall be as nearly as possible rectangular in form and shall be marked by two legal posts, one at each end of the claim, numbered "1" and "2" respectively. Location posts of creek claims shall be placed on the base line, and of all other claims parallel to the base line, and on the side of the claim nearest the creek or river towards which it fronts.

A discoverer shall be entitled to a claim 1,500 feet in length, and a party of two discoverers two claims, each of 1,250 feet in length.

The boundaries of any claim may be enlarged to the size of a claim allowed by the Act, if the enlargement does not interfere with the rights of other persons or terms of any agreement with the crown.

An application for a claim may be filed with the Mining Recorder within ten days after being located if within ten miles of the Recorder's office. One extra day shall be allowed for every additional ten miles or fraction thereof. A claim may be located on Sunday or any public holiday.

Any person having recorded a claim shall not have the right to locate another claim in the valley or basin of same creek within sixty days of locating first claim.

### Title

Any person having complied with the provisions of the Act with respect to locating and recording a claim shall be entitled to a grant for one year and shall have the absolute right of renewal from year to year thereafter, provided during each year he does or causes to be done \$200.00 worth of work of the claim, files with the Mining Recorder within fourteen days after the expiration of the claim an affidavit showing a detailed statement of the work, and pays the required renewal fee.

### GROUPING

Under certain conditions claims may be grouped and the work required to be performed to entitle the owner or owners to renewals of the several claims grouped may be performed on any one or more of the claims in the grouping. If the claims grouped are owned by more than one person a partnership agreement creating a joint and several liability on the part of all the owners for the joint working of the claims shall be executed and filed with the Mining Recorder.

### Taxes and Fees

Royalty at the rate of two and one-half per cent. on the value of all gold shipped from the Yukon Territory shall be paid to the Comptroller.

### QUARTZ MINING

Subject to the boundaries of other claims in good standing at the time of its location, a mining claim shall be rectangular in shape and shall not exceed 1,500 feet in length by 1,500 feet in width.

Every claim shall be marked on the ground by two legal posts, one at each extremity of the location line, numbered "1" and "2" respectively. On the side of No. 1 post facing No. 2 post shall be inscribed the name of the claim, a letter indicating the direction to No. 2 post, the number of feet to the right or left of the location line, the date of location and the name of the locator. On No. 2 post, on the side facing No. 1 post, shall be inscribed the name of the claim, the date of location, and the name of the locator.

The claim shall be recorded within fifteen days if located within ten miles of the mining Recorder's office; one additional day shall be allowed for every additional ten miles or fraction thereof.

Adjoining claims not exceeding eight in number may be grouped, the necessary representation work for each claim may then be performed on any one or more of the claims in the group.

Every application for a full claim shall be made on Form "A" and for a Fractional claim on Form "A-1".

No person is entitled to locate more than one claim in the same mining district within twenty days.

The timber on a mineral claim is reserved until the Mining Recorder certifies that the same is required for use in mining operations on the claim. The Commissioner, however, may issue a permit to holders of other claims to remove the timbers for use in their mining operations where other timber is not readily available.

### Title

Any person having complied with the provisions of the Act with regard to locating and recording a claim shall be entitled to hold it for one year from the date of the record and thereafter from year to year, provided during each year he does or causes to be done work on the claim to the value of \$100.00 and shall, within fourteen days after the expiration of the year, satisfy the Mining Recorder that the work has been done, and pay the Certificate of Work fee. One hundred dollars may be paid in lieu of assessment work.

When \$500.00 has been expended or paid the locator may, upon having a survey made, and upon complying with other requirements, obtain a lease for a term of twenty-one years with the right to renewal for further terms of twenty-one years. Claims located prior to July 7, 1917 may upon fulfilling similar requirements, be Crown Granted.

Leases, renewals of leases, and documents relating to leased claims shall be recorded with the Mining Recorder in triplicate.

### Dredging

A lease may be issued for a period of fifteen years for a continuous stretch of river not exceeding ten miles in length giving the exclusive right to dredge for gold, silver and platinum. The lessee must have at least one dredge in operation on the leasehold within three years.

### Petroleum and Natural Gas

A lease may be issued for a period of twenty-one years for an area of not to exceed 1,920 acres giving the right to the petroleum and natural gas on the area leased. A rental is charged of 50 cents per acre for the first year and \$1.00 per acre for each subsequent year.

### Assay Office

An Assay Office is maintained by the Government at Vancouver, where gold exported from the Territory will be purchased at its full value.

### OTTAWA EXTENDS FUELWOOD SUBSIDY.

OTTAWA, June 24.—Munitions Minister Howe today announced in the house of commons an extension to Dec. 31, 1943, of the period in which the government's subsidy of \$1 a cord on fuelwood will be paid to registered dealers.

The subsidy originally announced last March 4, fixed the expiration at June 30.

Mr. Howe said there was a continued serious shortage, prompting the extension. The subsidy payments go to registered dealers only, and assistance given toward transportation is also extended to slabwood, which dealers are encouraged to buy.
