HIGHWAYS ACT

Pursuant to section 3 and subsection 24(2) of the Highways Act the Minister of Highways and Public Works orders as follows

1. The Deputy Minister of Highways and Public Works may from time to time in accordance with this Order, exercise the power of the Minister under subsection 24(2) of the Act and section 8 of the Highways Regulation to reduce the maximum allowable gross vehicle weight or axle weight for a vehicle which may be operated on a highway or part of a highway to ensure the safety of persons using the highway or to prevent excessive damage to the highway.
2. (1) A reduction imposed under section 1 shall not exceed 50 per cent of the maximum allowable gross vehicle weight or axle weight for a vehicle which may be operated on a highway or any part of a highway.

(2) Despite subsection (1), there shall be no reduction in the maximum allowable gross vehicle weight or axle weight for vehicles with a registered gross vehicle weight of less than 12,000 kg.
3. The reduced maximum allowable gross vehicle weight or axle weight imposed under section 1 is the maximum allowable weight for the purposes of the Highways Regulation.
4. Notice of the reductions imposed under section 1 shall be given as required by section 8 of the Highways Regulation.
