# COUNCIL OF THE YUKON TERRITORY

DAWSON, THURSDAY, 5TH JULY, 1906. 3:00 o'clock P. M.

This being the first day of the Session of the Council of the Yukon Territory, for the despatch of business, pursuant to Summons of the Commissioner of the Yukon Territory, dated the nineteenth day of June, 1906, and the Council having met, the Commissioner took the chair.

The following petitions were presented:

By Mr. Macaulay,—Of Isidore McWm. Bourke, M. D., praying that a committee be appointed to consider his claim for attendance on indigents in the summer and fall of 1898. Referred to Committee on Standing Orders.

By Mr. *Lithyow*,—Of D. D. Sinclair and others, praying that the license fee for saloons in the City of Dawson be reduced. Referred to Committee on Standing Orders.

On motion of Mr. Girouard, seconded by Mr. Dugas, RESOLVED, That Select Standing Committees of the Council be appointed for the following purposes:

- 1. Standing Orders and Private Bills;
- 2. Public Accounts;
- 3. Mining;

which said Committees shall consist of five members each, and be severally empowered to examine and inquire into all such matters and things as shall be referred to them, and shall report from time to time their proceedings and findings, with power to send for papers, persons and records.

On motion of Mr. Lithgow, seconded by Mr. Girouard, RESOLVED, That a Special Committee consisting of Messrs. Lithgow, Black and Lowe, be appointed to prepare and report with all convenient speed, a list of members to compose the Select Standing Committees of the Council.

Mr. Lithgow begged leave to introduce a Bill entitled an Ordinance to amend the Assessment Ordinance.

He accordingly presented the said Bill, and the same was received and read the first time, and

Ordered to be read a second time at the next sitting.

Mr. Lowe begged leave to introduce a Bill entitled An Ordinance to Amend the Ordinance Respecting Public Health.

He accordingly presented the said Bill, and the same was received and read the first time, and

Ordered to be read a second time at the next sitting.

Mr. Senkler begged leave to introduce a Bill entitled An Ordinance to Amend the Ordinance Respecting the Preservation of Game.

He accordingly presented the said Bill, and the same was received and read the first time, and

Ordered to be read a second time at the next sitting.

Mr. Dugas begged leave to introduce a Bill entitled An Ordinance to Amend the Juries Ordinance.

He accordingly presented the said Bill, and the same was received and read the first time, and

Ordered to be read a second time at the next sitting

Mr. Lithgow begged leave to introduce a Bill entitled An Ordinance to Amend the Assessment Ordinance.

The following Petitions were presented:

By Mr. Black,—Of J. T. Carroll and others, praying that a wagon road be constructed on All Gold Creek.

By Mr. *Black*,—Of William P. Lynch and others, praying for an amendment to the Ordinance relating to steam boilers. Referred to Committee on Standing Orders.

Mr. Lithyow presented the following report:

Your Special Committee appointed to prepare a list of members to compose the Select Standing Committees of the Council, begs to report that it has prepared a list of members of such Committees as follows:

Standing Orders and Private Bills: Messrs. Girouard, Dugas, Wood, Macaulay and Lowe.

Public Accounts: Messrs. Lithgow, Senkler, O'Brien, Macaulay and Black.

Mining: Messrs. Senkler, Gillespie, O'Brien, Lowe and Black.

Ordered that the report be received and concurred in.

It was moved by Mr. Lithyow, seconded by Mr. Black, RESOLVED, That a Standing Committee be appointed ou Public Works.

It was moved by Mr. Lithgow, seconded by Mr. Black. RESOLVED, That a Special Committee consisting of Messrs. Lithgow, Black and Lowe, be appointed to prepare and report with all convenient speed, a list of members to compose the Select Standing Committee on Public Works.

It was moved by Mr. Lithgow, seconded by Mr. Girouard, RESOLVED, That a Committee consisting of Messrs. Lowe, Black, Macaulay, O'Brien and Gillespie, be appointed to consider the various Ordinances relating to Territorial Elections and Voters' Lists and to report to the Council any changes considered necessary therein.

It was moved by Mr. Lithgow, seconded by Mr. Girouard, WHEREAS, the practice has been heretofore pursued whereby all subsidies voted by the Parliament of Canada for the Yukon Council and paid by the Finance Department of Canada to the Canadian Bank of Commerce, Dawson, to the credit of the Yukon Council, have been placed by said bank to the credit of an account denominated "Local Revenues" and have been paid out of such account upon proper voucher by cheques of the Comptroller countersigned by the Commissioner of the said Territory as required by Order in Council of the 19th July, 1898, (P. C. No. 185).

AND WHEREAS, doubts have been raised by the said bank as to the technical regularity of such practice and a request made that the same be approved by this Council, THEREFORE, BE IT RESOLVED. That the said practice be approved and validated and its continuance authorized.

Mr. Black asked the following question:

What representations or petitions (if any) have been received by the *Commissioner* from the residents of Dominion or Sulphur Creeks regarding the completion of the highway road from 97 below lower Discovery on Dominion Creek to Jensen Creek; the completion of the highway road from 97 below lower Discovery on Dominion Creek to Granville, Dominion Creek; the completion of the highway road from the lower end of the existing highway on

said creek to connect with the highway road on Dominion Creek; and what action does the Government intend taking in regard to the same and when?

The Commissioner gave the following answer:

Two petitions dated March 15th, 1906, and signed by O. Lamarre and about 150 others, were received by the *Commissioner* on July 3rd, 1906, praying for the continuation of the Dominion Creek road from 97 below lower Discovery to the mouth of Gold Run.

A petition dated June 24th, 1906, signed by Jack Gleason and 18 others was received by the *Commissioner* on June 30th, 1906, praying that the road on Dominion Creek be extended from 97 below lower to Jensen Creek.

The Government proposes to build the road from 97 below lower on Dominion to Jensen Creek this summer, and to extend the road further down Dominion Creek as the development of the lower part of the creek warrants. The Government also proposes to complete the construction of the lower Sulphur Creek road this summer.

Mr. Gillespie asked the following question:

Has the Government of the Yukon Territory made, or does the Government intend to make, any provision for the transportation of prospectors into the Pelly River District this season?

The Commissioner gave the following answer:

No. The Government is, however, co-operating with the Royal North-West Mounted Police to secure free transportation for bona fide prospectors up the Pelly River on the Police boat "Vidette," in the event of that steamer making the trip.

Mr. Black asked the following question:

What contract (if any) has been made by or on behalf of the Government of Yukon Territory or any officer or Department thereof with one Hatfield, an alleged rain-maker; what amount of money (if any) has been paid or advanced to, or for said Hatfield by the Government or any officer or Department thereof for any purpose, and if any, for what purpose; what is the extent (if any) of the Government's liability in connection with the undertaking of said Hatfield to produce rain?

The Commissioner gave the following answer:

A contract was entered into with Charles M. Hatfield of Los Angeles, California, on August 10th, 1905, whereby the said Hatfield undertook to increase the natural rainfall to an amount sufficient to insure a successful and prosperous summer for the placer mining industry in the Dawson District to the satisfaction of a Board of seven; a copy of the said contract is attached hereto.

No amount of money has been paid or advanced to, or for said Hatfield by the Government or any officer or Department thereof for any purpose.

If the Board of seven referred to in the said contract decide that the said Hatfield has increased the rainfall to an amount sufficient to insure a successful and prosperous summer for the placer mining industry of the Dawson District, the Government under the contract is liable to pay him five thousand dollars. In the event of the said Board deciding that the said Hatfield has not increased the rainfall as aforesaid, the Government is liable to pay him for transportation of himself and one assistant and for his appliances from Los Angeles to the Yukon and back again to Los Angeles, together with the living expenses of himself and assistant during their stay in the Yukon Territory.

### Mr. Black asked the following question:

Has any rain been produced in the Yukon Territory by Mr. Hatfield; has any estimate or measurement been made by or on behalf of the Government of the quantity of rain produced by Hatfield in Yukon, and if not, why not?

The Commissioner gave the following answer:

The Board of seven authorized by the said contract to determine if the said Hatfield has increased the rainfall as set out in the said contract, has not yet advised the Government of its decision as to whether Mr. Hatfield has so increased the rainfall or not. Mr. H. T. Mackay, the Meteorological Agent for the Dominion Government, is keeping a record of the rainfall in Dawson.

## Mr. Black asked the following question:

What amount (if any) has been paid or advanced by

the Government or any officer or Department thereof to any person or corporation on account of the proposed installation of a hydrant system for water supply in Dawson since January 1st, 1906, and if any such payment or advance has been made, to whom, when, and upon what terms?

The Commissioner gave the following answer:

No amount has been paid or advanced by the Government or any officer or Department thereof to any person or corporation on account of the proposed installation of a hydrant system for water supply in Dawson since January 1st, 1906.

The Order of the Day being read for the second reading of the Bill (No. 1) Respecting Assessment,

The said Bill was read a second time, and

Ordered to be committed to a Committee of the Whole Council.

Council according to order resolved itself into a Committee of the Whole, and after some time spent therein, the *Commissioner* resumed the chair, and Mr. *Macaulay* reported progress and asked leave to sit again at this sitting.

Ordered that the Committee have leave to sit again at this sitting.

The Order of the Day being read for the second reading of the Bill (No. 2) respecting Public Health,

The said Bill was read a second time, and

Ordered to be committed to a Committee of the Whole Council.

Council according to order resolved itself into a Committee of the Whole, and after some time spent therein, the *Commissioner* resumed the chair, and Mr. *Macaulay* reported the Bill without amendment.

Ordered that the Bill be read a third time at the next sitting.

The Order of the Day being read for the second reading the Bill (No. 3) Respecting the Preservation of Game

The said Bill was read a second time, and

Ordered to be committed to a Committee of the Whole Council.

Council according to order resolved itself into a Committee of the Whole, and after some time spent therein, the *Commissioner* resumed the chair, and Mr. *Macanlay* reported the Bill without amendment.

Ordered that the Bill be read a third time at the next sitting.

Council according to order resolved itself again into Committee of the Whole on Bill (No. 1) respecting Assessment, and after some time spent therein, the *Commissioner* resumed the chair, and Mr. *Macaulay* reported the Bill with certain amendments.

Ordered that the report be received.

The amendments were then read twice and agreed to.

Ordered that the rules of the Council be suspended and that the Bill be immediately read a third time.

The Bill was accordingly read a third time.

Ordered that the Bill do now pass and be entitled An Ordinance to Amend Chapter 64 of the Consolidated Ordinances of the Yukon Territory, entitled The Assessment Ordinance.

The Order of the Day being read for the second reading of the Bill (No. 4) respecting Juries,

The said Bill was read a second time, and

Ordered to be committed to a Committee of the Whole at the next sitting.

The Order of the Day being read for the second reading of the Bill (No. 5) Respecting Assessment.

The said Bill was read a second time.

It was moved by Mr. Lithgow, seconded by Mr. Gironard, RESOLVED, That the Bill (No. 5) Respecting Assessment, be referred to a Special Committee consisting of Messrs. Macaulay, Lowe, Black, Senkler, Gillespic and the Mover.

The Order of the Day being read for the second reading of Bill (No. 6) respecting Constitutional and Territorial Questions,

The said Bill was read the second time, and

Ordered that the said Bill be committed to a Committee of the Whole Council at the next sitting.

The Order of the Day being read for the second reading of Bill (No. 7) respecting the City of Dawson,

The said. Bill was accordingly read the second time and,

It was moved by Mr. Lithyow, seconded by Mr. Girouard, RESOLVED. That the Bill (No. 7) respecting the City of Dawson be referred to a Special Committee consisting of Messrs. Macaulay, Black, Scakler, Lowe and the Mover.

Council then adjourned at 4:28 p. m.

#### MONDAY, 9TH JULY, 1906.

3:00 O'CLOCK P. M.

The following petition was presented:

By Mr. Gillespie,—Of J. P. Laumeister and others, praying that the Government of the Yukon Territory acquire the Klondike Bridge. Referred to Committee on Standing Orders.

Mr. Girouard presented the following report:

The Committee on Standing Orders begs to report that they have examined the petition of D. D. Sinclair and others praying for a reduction of saloon licenses and would not recommend that the prayer of the petition be granted, but would beg to recommend that the present license fee for hotels, viz.: \$700, be reduced to \$500, for all hotels in South Dawson, which will comprise for this purpose the Government Reserve and Day's Addition to the Townsite of Dawson.

Ordered that the report be received and concurred in.

Mr. Dugas asked the following question:

Have the prospectors transported by the "Vidette" last fall made any report as to what they have done, and have they been seriously prospecting?

The Commissioner gave the following answer:

The Government has not been advised as to what work was done by the prospectors transported by the "Vidette" last fall.

Mr. Black asked the following question:

Has any action been taken, or, is any action contemplated by the *Commissioner* or by the Government upon the petition presented at the last session of the Council by Mr. O'Brien, Member for South Dawson, asking for a free bridge between Dawson and Klondike City? If so, what action?

The Commissioner gave the following answer:

Instructions were given Mr. D. R. Macfarlane, Inspector of Works and Buildings, last October, to inquire into the value of the toll-bridge across the Klondike River, and to furnish estimates as to the cost of a new bridge. Instructions were also given Mr. G. I. MacLean, of the Comptroller's Office, at the same time, to examine the books of the management of the said bridge and to report upon its receipts and expenses. Reports were received from Messrs. Macfarlane and MacLean in accordance with these instructions. The Commissioner has also conferred with Mr. J. R. Howard, the owner of the bridge, and has had some correspondence with him with reference to the purchase of the bridge. The question of purchasing the bridge is now under consideration.

Mr. Black asked the following question:

What expenditures, if any, have been made or what liability incurred by the Government in connection with the prospecting, pumping or draining of Duncan Creek?

Has any machinery, and what, been purchased by the Government for such purpose, if so, at what price, from whom and where is the machinery?

What work is being done or is proposed to be done in the matter, where and on what terms, and who is in charge of the work on the ground, and on what terms?

What report, if any, has been received by the Commissioner in regard to the matter since the presentation of the report of the Standing Committee on Mining on the 9th September, 1905?

The Commissioner gave the following answers: An expenditure of \$4,125.16.

Yes. Two Cameron pumps, cost \$1,905.16. Purchased through the Dawson Hardware Company, the Government being allowed the trade discount off, and paying a commission of 10 per cent. on the actual disbursements. The pumps were imported duty free and the White Pass and Yukon Route made a special low rate on the freight. One 50 horse power boiler complete, with fittings, etc., purchased from Messrs. O. H. Clarke, H. G. Wilson and James McCalman, \$2,000.00. A quantity of pipes with flanges from E. H. Elwell for pumps, \$220.

The boiler is on No. 53 below Discovery, Duncan Creek. The pumps have been sent to Mayo. The pipes will be sent to Mayo on the next trip of the Prospector. The plant is in care of Mr. T. H. Hinton, Mining Recorder, Duncan District.

No work has yet been done, but it is proposed to take the pumps to Duncan Creek as soon as possible. The location, terms and time of the work are under consideration.

A report dated March 3rd, 1906, has been received from the Mining Recorder for Duncan Creek, Mr. T. H. Hinton, and many conferences have been held between the Commissioner and the said T. H. Hinton and miners interested on the creek.

The Order of the Day being read for the third reading of the Bill (No. 2) Respecting Public Health,

The Bill was accordingly read a third time.

Ordered that the Bill do now pass, and be entitled An Ordinance to Amend Chapter 9 of the Consolidated Ordinances of the Yukon Territory, "An Ordinance Respecting the Public Health."

The Order of the Day being read for the third reading of the Bill (No. 3) Respecting the Preservation of Game, The Bill was accordingly read a third time.

Ordered that the Bill do now pass, and be entitled An Ordinance to Amend Chapter 5 of the Ordinances of the year 1905, entitled An Ordinance to Amend Chapter 72 of the Consolidated Ordinances of the Yukon Territory, en-

titled An Ordinance Respecting the Preservation of Game in the Yukon Territory.

Council according to order resolved itself into a Committee of the Whole on the Bill (No. 4) Respecting Juries, and after some time spent therein the *Commissioner* resumed the chair, and Mr. *Girouard* reported progress and asked leave to sit again.

Ordered that the Committee have leave to sit again.

The Order of the Day being read for the second reading of the Bill (No. 8) Respecting Succession Duties,

The Bill was accordingly read a second time, and

Ordered to be committed to a Committee of the Whole Council at the next sitting.

Mr. Lowe begged leave to introduce a Bill respecting the closing of certain portions of streets in the Townsite of Whitehorse.

He accordingly introduced the said Bill and the same was read the first time.

Ordered to be read a second time at the next sitting.

And the Council then adjourned at 3:28 p. m.

#### TUESDAY, 10TH JULY, 1906. 3:00 o'clock P. M.

The following petition was presented:

By Mr. Gillespie,—Of T. F. Harkin and others, praying for the construction of a road along the right limit of Lovett Gulch. Referred to Committee on Standing Orders.

Mr. Lithgow presented the following report:

Your Special Committee appointed to prepare and report a list of members to compose the Select Standing Committee on Public Works, beg to report as follows:

Public Works: Messrs. Lithgow, Black. Dugas, Lowc and Gillespic.

Ordered that the report be received and concurred in.

It was moved by Mr. *Black*, seconded by Mr. *Gillespic*. That a Committee of this Council be appointed to pre-

pare a Memorial to the Government of Canada requesting that the law governing the Yukon Territory, and particularly those acts governing and defining the duties of the Commissioner and of the Yukon Council be amended so as to provide:

- 1. For giving to the elected Members of the Council more control and supervision over the expenditure of public moneys than they now have;
- 2. For the appointment of an Advisory Board, a majority of whom shall be elected members of the Council to advise with the *Commissioner* during recess in all matters of public expenditure.

And the Question being put,

And a debate arising thereon,

And the Question again being proposed, a division arose, and the names being called for, they were taken down as follows:

Yeas: Messrs. Black, O'Brien.

Gillespie.—3.

Nays: Messrs. Girouard.

Dugas, Senkler, Wood, Lithgow, Macaulay, Lowe.—7.

So it passed in the negative.

It was moved by Mr. *Dugas*, seconded by Mr. *Black*, WHEREAS, The Parliament of Canada, at its last session did, by an humble address, extend a most cordial invitation to His Most Gracious Majesty King Edward the VII., and Her Most Gracious Majesty, Queen Alexandra, to honour the Dominion of Canada with a visit during the present summer,

THEREFORE. BE IT RESOLVED. That this Council in Session assembled, concurs most heartily in the invitation extended in the said address of the Parliament of Canada, and expresses its fervent hope that their Gracious Majesties, if they visit this portion of the Empire, will ex-

tend their tour to this, the most northerly part of their great dominions.

Mr. Black asked the following questions:

- 1. Has a lien law for the protection of miners' wages as recommended by the Committee of the Council, been passed at Ottawa; if so, when does it come in force?
- 2. Is the text of such lien law available, or will the same be published by the Government here before the same becomes operative?

The Commissioner gave the following answers:

- 1. Yes; and is now in force.
- 2. A copy of the Order in Council was received here last week, and is available for public inspection. It is being published in the Canada Gazette. It is the intention of the Government to include it in the publication of this Session's Ordinances of the Council.

Council, according to order, resolved itself into Committee of the Whole on Bill (No. 6) Respecting Constitutional and Territorial Questions, and after some time spent therein the *Commissioner* resumed the chair, and Mr. *Girouard* reported the Bill without amendment.

Ordered that the report be received.

Ordered that the Bill be read a third time at the next sitting.

Council, according to order, resolved itself into Committee of the Whole on Bill (No. 8) Respecting Succession Duties, and -after some time spent therein, the *Commissioner* resumed the chair, and Mr. *Girouard* reported the Bill with certain amendments.

Ordered that the report be now received.

The amendments were then twice read and agreed to.

Ordered that the Bill be read a third time at the next sitting.

The Order of the Day being read for the second reading of the Bill (No. 9) Respecting the Closing of Certain Portions of Streets in the Townsite of Whitehorse,

The Bill was accordingly read the second time,

Ordered to be committed to a Committee of the Whole Council.

Council, according to order, resolved itself into Committee of the Whole, and after some time spent therein the *Commissioner* resumed the chair, and Mr. *Girouard* reported the Bill agreed to without amendment.

Ordered that the report be now received.

Ordered that the Bill be read a third time at the next sitting of the Council.

Council, according to Order, resolved itself into Committee of the Whole on the Bill (No. 4) respecting Juries, and after some time spent therein, the *Commissioner* resumed the chair, and Mr. *Girouard* reported the Bill with amendments.

Ordered that the report be now received.

The said amendments were then twice read and agreed to.

Ordered that the Bill (No. 4) be read a third time at the next sitting.

And the Council adjourned at 4:45 p. m.

By Mr. Macaulay,—Of J. M. McNeil, praying for an amendment to the Ordinance Respecting the Boundaries of Dawson and Klondike City Townsites. Referred to Committee on Standing Orders.

By Mr. Dugas.—Of Robert Hughes, Christopher Reid and Andrew S. Grant, praying that the amended legislation respecting dance halls be abolished. Referred to Committee on Standing Orders.

(Sessional papers No. 1.)

Mr. Girouard begged leave to introduce a Bill amend-

ing the Liquor License Ordinance.

He accordingly introduced the said Bill, and the same was read a first time and

Ordered to be read a second time at the next sitting.

The Order of the Day being read for the third reading of the Bill (No. 6) Respecting Constitutional and Territorial Questions,

The said Bill was accordingly read the third time.

Ordered that the Bill do now pass and be entitled An Ordinance Relating to the Decision of Constitutional and Other Territorial Questions.

The Order of the Day being read for the third reading of the Bill (No. 8) Respecting Succession Duties,

The said Bill was accordingly read the third time.

Ordered that the Bill do now pass and be entitled An Ordinance to Provide for the Payment of Succession Duties in Certain Cases.

The Order of the Day being read for the third reading of the Bill (No. 9) Respecting Streets in the Townsite of Whitehorse.

The said Bill was accordingly read the third time.

Ordered that the Bill do now pass and be entitled An Ordinance to close certain portions of Fifth Avenue and Lambert and Elliott Streets in the Townsite of Whitehorse, from use as streets by the public.

The Order of the Day being read for the third reading of the Bill (No. 4) respecting Juries,

The said Bill was accordingly read the third time.

Ordered that the Bill do now pass and be entitled An Ordinance to amend Chapter 1 of the Ordinances of the year 1905, entitled "The Juries Ordinance."

And the Council then adjourned at 3:21 p. m.

### THURSDAY, 12TH JULY, 1906.

By Mr. Gillespie,—Of the North American Transportation and Trading Company, praying for re-imbursement in connection with the construction and maintenance of an

Mr. Black asked the following question:

Under what contract, if any, is the public printing of the Territory being done, and with whom is the contract made and what are its terms? If no contract exists, upon what terms is said printing being done and by whom?

The Commissioner gave the following answer:

- 1. In November a verbal agreement was made between the Manager of the Yukon World and the King's Printer, fixing the rate of advertising at \$1.50 per inch for first insertion and \$1.00 for subsequent insertions.
- 2. By letter dated 23rd February, 1906, (File 3284), a schedule of prices for job work was agreed upon, between the Acting Commissioner and John R. Grey, Manager, Yukon World. This agreement expired on the 30th June, 1906.
- 3. At the present time the said prices for advertising are continued and the prices for printing books, forms, etc., are arranged between the Yukon World and the King's Printer, but in no case exceed the prices coutained in the said agreement.

The Order of the Day being read for the second reading of the Bill (No. 10) Respecting the Liquor License Ordinance,

The said Bill was accordingly read the second time, and

Ordered to be committed to a Committee of the Whole Council at the next sitting.

Canada relating to criminal trials for indictable offences apply to the Yukon Territory without the limitations of said section 66 of said North-West Territories Act.

It was moved by Mr. Lithgow, seconded by Mr. Girourard, RESOLVED, That this Council will, at its next sitting, resolve itself into a Committee to consider of the ways and means for making good the Supply to be granted to the Commissioner.

It was moved by Mr. Dugas, seconded by Mr. O'Brien, That the Commissioner be instructed to communicate on behalf of this Council with the Departments at Ottawa which are more particularly connected with the administration of this Territory but more specially with the Department of the Interior, and to represent that too long delays very often occur in answering applications, public or private communications interesting this Territory and in the granting of titles; and that if consideration is given to the fact that the cost of life in this Territory is extraordinarily high, other communications with the exterior long and expensive, and that the mining industry is about the only one, it can be understood that to be kept in abeyance and in the expectative for months and years, can only create hardship, discouragement and be extremely detrimental to the people of this Territory.

And the Question being proposed, a division arose, and the names being called for, they were taken down as follows:

Yeas: Messrs. Dugas, O'Brien, Lithyow, Macaulay, Lowc, Senkler, Black.—7.

Nays: Messrs. Girouard, Wood.—2.

So it was resolved in the affirmative.

Mr. Black asked the following question:

What arrangement, if any, has the Government made, or what arrangements will be made by the Government for changing the location of the highway road on the north side of the Klondike River, between the Ogilvie Bridge and the mouth of the Klondike River, the change being necessitated by the operation of a dredge in the Klondike basin by private owners? Does the Government propose to bear any of the expense of the change of location of the road or construction of a new road, and if so, what part of the expense?

If the road is removed from its present location for the benefit of the operation of such dredge, what does the Government intend doing in the matter of damages caused by such change of the public highway to property owned by private individuals? The Commissioner gave the following answer:

A change in the location of the Government road on the Klondike Flat west of Ogilvie Bridge is being considered. Mr. MacPherson, Director of Surveys, has, on request of the Public Works Department, made a preliminary survey around the base of the hill; and negotiations have taken place with the Managers of the Dredging Company (on account of whose operations the change is necessary) with a view to secure their co-operation in constructing the proposed road.

A temporary road has been built around the dredge so as to permit dredging across the Government road. The dredging company contributed to the construction of this temporary road. If a new road is deemed necessary and its construction interferes with any private rights they will be protected.

Mr. Gillespie asked the following question:

To whom were the amounts mentioned on page 9 of the Statement of Revenue and Expenditure of the Yukon Territory for the year ending June 30th, 1906, under the head "Dawson Quartz Mill" paid, and under what contract or agreement?

The Commissioner gave the following answer:

The said amounts were paid to D. A. Matheson under a contract which expired on the 18th December, 1905.

Council, according to order, resolved itself into Committee of the Whole on the Bill (No. 5) respecting Assessment and after some time spent therein, the *Commissioner* resumed the chair, and Mr. *Girouard* reported progress and asked leave to sit again.

Ordered that the Committee have leave to sit again.

Council, according to order, resolved itself into Committee of the Whole on the Bill (No. 7) respecting the City of Dawson, and after some time spent therein, the Commissioner resumed the chair, and Mr. Girouard reported progress and asked for leave to sit again.

Ordered that the Committee have leave to sit again.

And then the Council adjourned at 3:45 p. m.

Your Committee have considered the Petition of William P. Lynch and others (being the miners of Gold Run and Lower Dominion Creeks) praying that the law requiring an engineer's license for managing boilers be repealed.

Your Committee beg to recommend that this Petition be not granted, but recommend that Section 1 of Chapter 19 of the Ordinances of 1903 be amended by striking out the word "fifteen" in the second line thereof and substituting therefor the words "twenty-four."

Your Committee have also considered the Petition of J. M. McNeil, praying that the Ordinance and its description and limitation of the boundaries of Dawson and Klondike City Townsites be so amended as to permit of the location of placer mines extending over the Klondike and Yukon River beds between low and high water mark and outside of the Klondike Mines Railway right-of-way, or any other ground the working of which would not in terrupt, incommode, interfere with or disturb any present property rights of any person.

Your Committee beg to recommend that this petition be deferred until the next session of the Council.

Ordered that the report be received and concurred in

Mr. Lowe presented the following report:

Your Select Committee appointed to consider the Voters' Lists and Election Ordinances and make recommendations with regard to amendments thereto, begs to report that it has had these Ordinances under consideration, and respectfully recommends that an Ordinance amending the same be introduced along the lines of the attached draft Ordinance. (Sessional papers No. 2.)

Ordered that the report be received and concurred in.

Ordered that the Rules of the Council be suspended and that Mr. Lowe have leave to introduce a Bill respecting Voters' Lists for election to the Yukon Council.

Mr. Lowe accordingly presented the said Bill, and the same was read a first time, and

Ordered to be read a second time at the next sitting.

He accordingly introduced the said Bill and the same was read the first time.

Ordered to be read a second time at the next sitting. It was moved by Mr. Black, seconded by Mr. Gillespie,

That the Council adjourn until tomorrow at 3 p. m. On division the motion was negatived.

It being 6 oclock the Commissioner left the chair.

Ordered that the report be now received and concurred in.

- 1. As respects the two Petitions for a road into the Black Hills Districts, it would recommend that the Commissioner, after due inquiry, spend such sums as he sees fit.
- 2. As respects the Petition for a road on Lovett Gulch, it would recommend that the Commissioner ascertain the cost of same and expend such sums as he sees fit.
- 3. As respects the Petition for a road on All Gold Creek, it would recommend that inasmuch as said road would cost a very large sum it be not built, especially as there is already a sum voted to repair the existing road.
- 4. As respects the claim of the North American Transportation and Trading Company the Committee is of the opinion that, on account of the representations made, to a certain extent the work was authorized by the then Acting Commissioner and that there is a conflict as to whether it was for the public interest, though the weight of the evidence is that it was.

The Committee recommends that the amount be paid, but at the same time wants it to be understood that this

should not be taken as a precedent under similar circumstances.

5. In regard to the Klondike Bridge the Committee is of the opinion that sufficient data has not been presented to them to form an opinion as to the opportunity of entertaining the Petition, and recommends that the matter be postponed until next session, and that, in the meantime, the Commissioner take proper steps to be in a position to then inform the Council.

That a Committee of this Council be appointed to prepare and forward an address to the Governor-General of Canada praying for the cancellation of all hydraulic concessions and leases in the Territory fraudulently obtained, the terms of which have not been complied with.

 $Mr. \ Senkler$  moved in amendment, seconded by  $Mr. \ Wood$ ,

That the Debate be adjourned.

And the Question being put on the amendment, a division arose, and it was resolved in the affirmative.

Mr. Black asked leave to introduce a Bill respecting the Judicature Ordinance and Rules.

He accordingly introduced the said Bill and the same was read the first time.

Ordered that the Rules of Council be suspended and that this Bill be read a second time at this sitting.

Mr. Black asked leave to introduce a Bill respecting the Collection of Debts.

He accordingly introduced the said Bill and the same was read the first time.

Ordered that the Rules of Council be suspended and that this Bill be read a second time at this sitting.

Mr. Black asked the following questions:

Have any of the following hydraulic concessions or leases been cancelled by the Government: the Bronson & Ray; the Boyle; the Matson and Doyle; the Herman; the Slavin and Gates (Quartz Creek); the Anderson; if so, when were they cancelled?

If not, is it the intention of the Government to cancel any of the same?

When will notice of cancellation be given to the public?

When will the ground within any of the above concessions be thrown open for staking by the public?

What proceedings, if any, are being carried on now by the Government for the cancellation of any of the above concessions; and at what stage are the proceedings?

The Commissioner gave the following answer:

The matters referred to in these questions are not dealt with by this Government, and I, therefore, am not in a position to give the information asked for.

The Order of the Day being read for the third reading of the Bill (No. 5) Respecting Assessment,

It was moved by Mr. Lowe, seconded by Mr. Gillespie.

That the bill be not now read a third time, but that it be referred back to Committee of the Whole for further amendment.

And the Question being proposed, it passed in the negative.

It was moved by Mr. Macaulay, seconded by Mr. O'Brien,

And the Question being proposed, it passed in the negative.

Ordered that the report be received.

The amendments were then twice read and agreed to.

Ordered that the Rules of Council be suspended and that the Bill be immediately read a third time.

The Bill was accordingly read the third time.

Ordered that the Bill do now pass and be entitled An Ordinance to amend Chapter 3 of the Consolidated Ordinances of the Yukon Territory and Chapter 18 of the Ordinances for the year 1904, entitled "An Ordinance to provide for Voters' Lists for election to the Yukon Council.

On motion of Mr. Black, seconded by Mr. Gillespie. RESOLVED, That the Rules of the Council be suspended in order that the above Committee may be authorized to sit and act after the conclusion of the Session.
