## COUNCIL OF THE YUKON TERRITORY

THURSDAY, APRIL 4TH, 1918.

3 o'clock P. M.

This being the first day of the Second Session of the Fourth Wholly Elective Council of the Yukon Territory, pursuant to a proclamation of the Administrator of said Territory, dated the 6th day of March, 1918, with the following Members present: Messrs. O'Brien, Landreville, Salter, Lowden, Wilson and McMillan.

The Clerk informed the Members of the unavoidable absence of Mr. Speaker.

Mr. O'Brien, thereupon addressing himself to the Clerk, proposed to the Council that Mr. Landreville be elected pro tempore as their Speaker, which resolution was seconded by Mr. Wilson.

The question being put by the Clerk, it was resolved that *Maxime Landreville*, Esquire, do take the Chair of this Council as *Speaker*, pro tempore, and the Clerk having declared *Maxime Landreville*, Esquire, duly elected as *Speaker*, pro tempore, he took the Chair and thanked the Members for the honour.

It was moved by Mr. O'Brien, seconded by Mr. Low-den:

That the following telegram be sent to the Minister of the Interior, at Ottawa:

"Minister of Interior, "Ottawa.

"By Order of Members of Yukon Council, assembled

pursuant to proclamation of Administrator published sixth March last, I am directed to wire you as follows:

"'Members of the Council request that before drastic changes are made in the Government and administration of the Territory the Council be given opportunity to express an opinion regarding same. The Conucil is uninformed as to changes already made or those proposed to be made.'

Ordered, That the Gold Commissioner be requested to send the following telegram to the Minister of the Interior:

"I am directed by the Council in session today to advise you that the Council, after full consideration of the estimated revenue and strictest economizing in expenditures that unless the Federal grant is increased to one hundred thirty-five thousand dollars, the mining industry and public service of the Territory will be seriously affected, and respectfully request that such additional grant be made and Council notified at earliest date, if possible this week, of your decision, so that work of the Council may be proceeded with."

Mr. Landreville asked the following questions and Mr. Speaker gave the following answers:

- 1. Was there any repairs necessary and done on three ferries, to-wit, Yukon Crossing, Pelly Crossing and Stewart Crossing? Answer: Yes.
- 2. What was the nature of such repairs, if any were done? Answer: Stewart Crossing ferry removed from south side of the river in the spring of 1917, where it had frozen in the previous fall; general repairs in the nature of seams caulked with oakum and pitch, rope supplied, and cables greased. Pelly Crossing ferry, small repairs, in the nature of tallow and rope supplied, and seams caulked. Yukon Crossing ferry, sheaves turned

and general repairs made in the spring; last fall the ferry was sheathed on one side to protect from ice.

- 3. The names of the men employed on such repairs and the number of days paid to every one of such men employed? Answer:
- W. McIntyre, 17 days, \$127.50; A. Shaver, 11 days, \$82.50; F. C. Ward, 15 days, \$112.50, and Jos. Viaux, 4 days, \$30.00.
- 4. What was the wages paid per day? Answer: \$7.50.
- Mr. Landreville asked the following questions and Mr. Speaker gave the following answers:
- 1. Was George Fulton working for the Government of the Yukon Territory from November 1st to March 31st, 1918? Answer: Yes.
- 2. What was the said George Fulton doing? Answer: Taking care of 2 teams of horses belonging to the Government and working on the Government roads.
- 3. Is the said Fulton paid by the day or by the month? Answer: By the day.
- 4. Is the said Fulton receiving \$175.00 per month for the time mentioned in question 1, as was paid before him for the same work? Answer: No. The same work was not performed by former occupants of the position now held by Mr. Fulton. Formerly it required two men to keep open the roads that Mr. Fulton is now doing.
- 5. Is the said Fulton receiving more than \$175.00; if so, how much more and who recommended and authorized said raise of wages for his work? Answer: Yes, \$7.50 per day. The Superintendent of Works and Buildings in 1915.
- Mr. Lowden asked the following question and Mr. Speaker gave the following answer:

What reply has been received to the memorial passed at the last session of the Council, respecting the exemption of the prospector from the payment of royalty tax? Answer: The memorial was acknowledged and stated that as it would require legislation it was doubtful if it could be accomplished at that session.

Mr. O'Brien asked the following question and Mr. Speaker gave the following answers:

- 1. Was the memorial of the Council of the Yukon Territory passed at the last session of the Council respecting women's suffrage forwarded to Ottawa, and on what date? Answer: Yes. On May 2nd, 1917.
- 2. What reply has been received? Answer: Acknowledgement stating that in so far as the memorial required legislation it was doubtful if the same could be put through at that session.

Mr. Wilson asked the following questions and Mr. Speaker gave the following answer:

- 1. Did the Administrator take up with the proper authorities at Ottawa the resolution passed at the 1916 session of the Council respecting destruction of wolves, coyotes and other noxious animals? Answer: Yes.
- 2. What results have been accomplished? Answer: The matter of destruction of wolves and coyotes for the protection of game animals and birds has been under consideration by the Dominion Department of Agriculture and has been held in abeyance until Dr. C. Gordon Hewitt, the Dominion Entomologist, has had an opportunity to take up the matter with the authorities at Washington with a view of establishing a systematic campaign against wolves and coyotes in Alaska and Yukon. War conditions are no doubt responsible for delayed action.

The Orders of the Day being read for the second reading of Bill (No. 4), being an Ordinance to amend the Yukon Game Ordinance.

Council, according to Order, resolved itself into a Committee of the Whole on the motion of Mr. *Phelps*, and, after some time spent therein, the *Speaker* resumed the chair, and Mr. *O'Brien* reported as follows:

Whereas, The Council at this session has passed an Election Ordinance whereby the expenses of holding a general Territorial election will be reduced from the former cost of upwards of \$10,000.00 to a sum not exceeding \$2,500.00;

And, Whereas, A wholly elective Council of ten members was granted the Territory to meet the wishes of the majority of its electors, and after several years in which the system of appointing government officials to the Council was wholly unsatisfactory to the people of the Territory;

And, Whereas, Council has been advised by Message from the Commissioner that it is the intention of the Dominion Government to abolish the Yukon Council, and substitute therefor a simpler form of Government;

Be it, therefore, Resolved, That this Council respectfully submits to the Dominion Government for its consideration the following:

- 1. That considerable sums are raised each year by local taxation, and the tax payers are entitled to representation in any Government levying and expending such taxes.
- 2. That by reason of the distance of the Yukon Territory from Ottawa, and the delay and uncertainty in communicating between these places, all local matters should be considered and disposed of in the Territory.
- 3. That this Territory still has vast mineral resources; the people here are familiar with its requirements, and have shown their faith in it by investing their

money and enduring its hardships for the past twenty years, and by reason of such are entitled to particular consideration from the Government.

- 4. That this Territory has loyally responded to the call for men and money to fight the battles of the Empire in which the maintenance of representative government is one of the issues.
- 5. That we recommend that the Yukon Act be amended reducing the number of representatives to be elected to the Council from ten to five, one from each district, so that the cost of holding a session of the Council each year would not exceed the sum of \$3,500.00, and we further recommend that the Commissioner preside over all meetings of the Council.
- 6. That the present Council was elected in March, 1917, the term being for three years, and should be granted the right to hold another session.
- 7. That any other form than that of representative government would be unsatisfactory and repugnant to the people of this Territory, the large majority of whom are British subjects.

Be it further Resolved, That the Commissioner be requested to forward a copy of this Resolution to His Excellency the Governor General, to the Right Honourable Sir Robert Borden, to the Right Honourable Sir Wilfrid Laurier, to each Minister of the Dominion Government and to the Member for Yukon, and that a telegram be sent to the Honourable Arthur Meighen, Minister of the Interior, requesting that no further change be made in the Territorial Government pending the receipt of this Resolution.

On motion of Mr. O'Brien, seconded by Mr. Fraser: Ordered, That the report be received and concurred in. Moved by Mr. Fraser, seconded by Mr. McMillan: Resolved. That in the event of the amount received

from liquor licenses issued for the premises within the City of Dawson during the year 1918 be in excess of \$4,900.00, the portion of liquor license fees voted to the said City of Dawson at this session of Council, the sum so in excess of \$4,900.00 shall be paid out of the Territorial Revenue Fund to the City of Dawson.

Moved by Mr. Phelps, seconded by Mr. Landreville:

Resolved, That the sum of \$6,000.00 grant to the Good Samaritan Hospital be expended by the Commissioner in liquidating the debts of the said hospital on condition that the Board or Trustees of the Good Samaritan Hospital transfer to the Commissioner of the Yukon Territory such control over the property and assets of said hospital as is now vested in it, such property and assets to be used only for hospital purposes.

On motion of Mr. Fraser, seconded by Mr. Phelps:

Ordered, That the Rules be suspended and that he have leave to introduce a Bill entitled "An Ordinance for granting to the Commissioner Certain Sums of Money to Defray the Expenses of the Public Service of the Yukon Territory."

He accordingly presented the said Bill (No. 10), and the same was received and read a first time.

Ordered, That the Rules be suspended and that the Bill (No. 10) be now read a second time.

The Bill (No. 10) was accordingly read a second time.

Council, according to order, resolved itself into a Committee of the Whole on Bill (No. 10), being an Ordinance for granting to the Commissioner certain sums of money to defray the expenses of the Public Service of the Yukon Territory, and, after some time spent therein, the Speaker resumed the chair, and Mr. O'Brien reported the Bill (No. 10) without amendments.

On motion of Mr. Fraser, seconded by Mr. Phelps: Ordered, That the Rules be suspended and that the Rill (No. 10) be now read a third time.

The Bill (No. 10) was accordingly read a third time.

Ordered, That the Rules be suspended and the Bill (No. 9) be now read a third time.

The Bill (No. 9) was accordingly read a third time.

Ordered, That the Bill (No. 9) do now pass and be entitled "An Ordinance for the Protection of Persons Serving in the Forces Raised by the Government of Canada in Aid of His Majesty and of Other Persons."

On motion of Mr. Phelps, seconded by Mr. Fraser:

Ordered, That the Rules be suspended and he have leave to introduce the following Resolution:

The Gold Commissioner has decided to reserve assent to the Bill entitled "An Ordinance Respecting Elections" for the reason that he is advised by the Federal Government that it is the intention to abolish the Yukon Council, and, in view of this fact, the expense of printing this Ordinance at this time is not justified.

And then the Clerk informed the Council that the Gold Commissioner would not require the attendance of the Honourable Members further at this session.

I have the honour to submit my report as Territorial Secretary and King's Printer for the year ending March 31st, 1918.

The first session of the Fourth Wholly Elective Council of the Yukon Territory assembled on the 5th day of April, 1917, and the business was completed on the 24th day of April, 1917, on which day it was prorogued by the Administrator. During the session nine Ordinances were passed and assented to and several Memorials and Resolutions on matters of interest to the Territory were adopted. All members of the Council were present.

# OFFICIAL GAZETTE.

The Gazette continues to be published in the "Dawson Weekly News," issued on Friday of each week.

# BARRISTERS, DENTISTS AND DRUGGISTS.

Two Barristers and Solicitors were admitted to practice, and six Barristers and Solicitors paid their annual fees. Two Dentists paid their annual fees, being a decrease of one; and four Druggists and Chemists paid their annual fees.

# BIRTHS, MARRIAGES AND DEATHS.

The Registrar of Births, Marriages and Deaths has furnished this Department with copies in duplicate of the Returns, one of which has been forwarded quarterly to the Dominion Statistician of the Census Department at Ottawa.

# PHYSICIANS AND SURGEONS.

Under the Physicians and Surgeons Ordinance one Physician and Surgeon was admitted to practice, and five have paid their annual fees.

# ENGINEERS' CERTIFICATES.

Eight Engineers' Certificates were issued during the year, being an increase of three.

# MOTOR VEHICLES.

Ninety-two motor vehicles were registered during the year, an increase of nine over the past year.

# PRINTING AND PUBLISHING.

I have the honour to submit the annual report of the schools of the Yukon Territory for the school year ending June 15, 1917.

Three regular schools were maintained throughout the year, viz.: Dawson Public School (seven departments); St. Mary's R. C. School (two departments); Whitehorse Public School (three departments).

Three Assisted Schools were in operation, viz.: Gold Bottom, Bonanza and Mayo Landing.

Of the above, the 55 pupils in Standards V. to VIII. were doing high school work.

During the year 1916-17 the Whitehorse School, for the first time in its history, had three departments and was supplied with laboratory equipment to enable the staff to institute a regular high school course. Two pupils of that school are expected to write on the Junior Matriculation Examinations next June. Better blackboards are sadly needed at Whitehorse, and I would urge that sufficent funds be provided for the purchase of hyloplate, boards, a material that has proved highly satisfactory during the past year in the Dawson School.

During the school year 1917-18 only two assisted schools have been required, viz.: at Bonanza and Mayo Landing. The latter is in charge of Miss Edith Murphy, who has had twelve pupils nearly all year. The Bonanza School was continued up to December, 1917, under Wil-

liam Galpin, who was instructed to close it shortly before Christmas as the attendance had fallen below the required number. It now seems unlikely that a school will again be required at that place.

The Dawson School Building is now well equipped in almost every particular and is well lighted and heated. Some more hyloplate should be purchased to complete the renovation of the boards.

SIR:

In response to your request for a further report on the Schools of this Territory, I beg to submit the following supplementary report, embodying statistics of attendance up to the present and certain suggestions with a view to lessening the expenditure.

During the present school year provision has been made for the maintenance of three permanent schools, namely, Dawson Public School, St. Mary's R. C. Separate School and Whitehorse Public School, and of such assisted schools as might be found necesstry. To avoid the necessity of an assisted school at Bear Creek, provision was made for the transportation of all children of school age daily to and from Dawson, the present contract including all who reside between Ogilvie Bridge and

No. 54 Below Discovery on Hunker Creek, and involving an expenditure of about \$3,250.00 per annum.

Assisted schools were maintained at the Town of Bonanza from September to December last; also at Mayo Landing. The latter should continue till June. After the next summer vacation a school will probably be needed again at Mayo Landing at an approximate cost of \$1,350.00 for the year. Twelve children were in regular attendance there up to last report. It seems improbable that any assisted school will have to be provided for elsewhere, unless the transportation of children from Bear Creek is discontinued. In the latter case \$1,350.00 or \$1,500.00 should be appropriated for an assisted school at that point. In case the transportation policy is to be continued, a policy which is decidedly the better since it provides graded schools, good equipment and expert teaching for the children concerned, I beg to suggest that a considerable reduction in cost might be effected (a) by limiting the transportation, for which the Government pays, to such children as reside at Bear Creek or can gather at that centre without expense to the Government, since that is the most distant and only centre which would be entitled under any circumstances to an assisted school, the children beyond this point being few in number and scattered at great intervals to a distance of about ten miles beyond Bear Creek; (b) by making no provision for the transportation of children who live in the vicinity of Ogilvie Bridge, unless they can be accommodated in the same car which conveys the children between Bear Creek and Dawson without making an extra trip. At present an extra trip of a car has to be paid for at \$75.00 or \$100.00 per month to transport these children who live less than two miles from school; (c) by paying on a strictly per diem basis for this service, the contractor receiving a flat rate per day for every school day the children are actually conveyed from and to Bear Creek.

If both schools are to be continued in Dawson as heretofore, comparatively little reduction in expenditure can be made, but a study of comparative statistics annexed to this report may assist in dealing with the question.

The capacity of the Dawson School is not now and never has been strained. The building has eight class rooms, and, allowing one to be set aside permanently for laboratory purposes, the seven remaining would easily accommodate from 250 to 275 pupils. It costs approximately the same, apart from the teaching staff, to maintain the Dawson Public School whether 100 or 250 pupils are in attendance, the cost of fuel, light, janitor service, cleaning and repairs being but little affected by the number of pupils attending. The Superintendent of Public Works might be able to suggest some method of cutting down the present cost of these items. I think they can be cut a little. However, the statistics of attendance to date will show that no reduction in the teaching staff is justified by purely present conditions unless the kindergarten department be entirely done away with. I hesitate to recommend this as an extreme measure, parparticularly since during the present school year the teacher of this department has for the first time assisted in the primary work by taking nine of the youngest pupils of the primary grade and thus relieving the primary department of congestion, and of the necessity of having too many classes for efficient work. However, it is the only department under present circumstances which could be abolished without serious injury to the public interest.

In all respects I contend that this school is not now by any means overstaffed, but it seems likely that a considerable shrinkage will take place next fall, and one department might be eliminated in that expectation.

I beg to suggest the following staff as a minimum in addition to myself (as explained below):

One high school teacher, male, at \$250.00 per month.

One high school teacher, female, at \$200.00 per month.

Three teachers of the grades, \$175.00 per month.

One kindergarten-primary, at \$175.00 per month.

The suggested schedule means a school of six departments instead of seven, and the saving of one salary amounting to \$200.00 per month as compared with the present schedule.

The statistics for St. Mary's and Whitehorse Schools are also annexed to this report. Regarding Whitehorse, it may be said that the Government two years ago added one room to the building, put in some laboratory equipment and added one member to the staff at a salary of \$185.00 per month. While it would be most regrettable to consider a return to the former status of a two-teacher school, it may be observed that the attendance at this school has not increased, but is smaller than it was a few years ago, and has barely held its own recently, the average enrolment last term in all three departments combined being 41.

I might add that ever since my appointment to my present position, I have been a "working" head of the department, not only being responsible for the appointment or dismissal of all the teachers in the public schools and the general management and course of studies pursued in these schools, but also making myself responsible for the language and history branches in the various grades of the Dawson senior high school department and teaching throughout each school day besides discharging the duties of principal of the Dawson School, being responsible for the grading of the pupils, the allotment of classes among the various departments and the general maintenance of discipline throughout the school.

In considering any readjustment of the teaching staff that may be thought imperative under existing financial conditions, it should be remembered that all the present teachers in the permanent schools are rightfully entitled to their present salaries to the end of the school year in August next.

Tables showing attendance during the present school

year in various schools and comparative statistics for former years are attached.

#### REPORT OF TERRITORIAL ASSAYER.

Whitehorse, Y. T., 1st March, 1918.

George N. Williams, Esq., Administrator, Yukon Territory, Dawson, Y. T.

SIR:

I have the honor to submit a statement of the work done in this office during the twelve months preceding March 1st, 1918, together with a brief summary of conditions in hard-rock mining in the Territory.

During the above mentioned period, 1,278 samples of rock were received for assay, and 1,662 assays or quantitative estimations were made, comprising nine elements.

In addition to the above, numerous qualitative determinations or tests were made in connection with the identification and classification of various rocks and minerals.

A detailed statement is attached to this report showing the various elements for which assays were made, and the different localities from which the samples were received.

In the Whitehorse District, copper mining has been quite active throughout the year. After being closed down for about four months, mining operations were renewed on the Pueblo mine, by the Atlas Copper Co., Ltd. This company started dewatering the mine on the 12th July, and reached the 500-foot level on the 19th ingust. Mining and shipping of ore was resumed on the 24th, and from this date until the mine shut down, in October, 1,336 tons of high grade copper ore were shipped to the smelter. The Grafter mine operated until fall, when it was shut down, during which time 3,500 tons of ore were shipped. This mine employed an average force of fifteen men. The Valerie copper mine has been steadily working since last spring. To date over 4,000 tons of ore have been shipped to the smelter. An average of twentyfive men are employed at the mine. The Copper King mine has also been steadily working, and has shipped over 1,200 tons outside. An average of ten men are employed at this mine. The War Eagle mine shipped out over 1,300 tons. The mine was closed down during the intense cold weather this winter, but will resume operations in the early spring. The Anaconda copper mine is under bond to outside parties, and it is expected that extensive operations will be commenced in the spring.

In the Wheaton River District, the owners of the Tally-Ho and Whirlwind groups have been sacking ore all winter preparatory to shipping. Fifteen tons of ore averaging about \$60.00 per ton in gold and silver has been hauled from the Tally-Ho mine to the railway, and is now ready to ship. On the Whirlwind group, a small concentrating plant of a capacity of fifteen tons per day has been secured, and will be ready to start up as soon as the water runs. Enough ore has been blocked out to keep the mill running for two years.

In the Conrad District, the Big Thing mine was opened up by Col. Stevenson, on February 10th of last year, and operated until October 26th, when the mine was closed down. An average of eight men were employed and about 750 tons of ore were broken up, sorted, and sacked for shipment.

The Caribou Mining Co., on Windy Arm, has done considerable work on the Venus Extension mine. The main tunnel was advanced 265 feet, and over 200 feet of raising was done from this tunnel on the vein. A small shipment of ore was made to Trail smelter in the fall, and about 150 tons are now ready for shipment.

The Venus mine, in the same district, has shipped out about 1,150 tons since last spring.

On Williams Creek, near Yukon Crossing, considerable work has been done during the past year on the Lucky Boy and Bonanza King copper properties. The ore is quartz impregnated with copper minerals carrying good values in gold and silver, as well as copper.

In the northern part of the Territory, quartz mining has been confined chiefly to development and assessment work.

Owing to the embargo on tungsten and molybdenum minerals having been removed by the Government, it is expected that shipments of these minerals will be made during the present year.

# REPORT OF SUPERINTENDENT-OF WORKS AND BUILDINGS.

Dawson, Y. T., April 12th, 1918.

George P. Mackenzie, Esq., Gold Commissioner, Dawson, Y. T.

SIR:

I beg to submit the annual report of the Superintendent of Works and Buildings for the fiscal year ending 31st March, 1918.

#### DAWSON PUBLIC SCHOOL BUILDING.

All necessary sections painted, floors and stairways oiled and varnished, new floor laid in cloak room and hall floor repaired. Several doors were repaired and locks renewed.

A new bookcase for Superintendent Bragg's room was supplied. Rear north stairway was repaired; walls of basement were reinforced with building paper and six loads of sawdust for inside banking purposes were hauled by Government teams.

Ground floor of basement was levelled, filling deep holes and unevenness caused by the heat thawing ice in the muck bottom.

Line of pipe laid from boiler to lower toilet rooms so as to avoid freezing up of same during cold weather.

General repairs were also made to roof and gutter pipes, and supplies have been purchased, such as paint, oil, varnish, glass, putty, chemicals, hose tools, packing, brooms, lamps, nails, chair seats, soap, electric light fittings, oilcloth, lumber and fittings.

The exterior of basement was banked with soil and tamped by Government teams and crew.

The following material was used for the improvement of the school grounds: Six loads of rock, 4 loads of sand, 11 loads of soil and 3 loads of cinders.

Grass on grounds was cut and hauled away.

GLACIER WINTER ROAD VIA SWEDE.

Bridge renewed on O. K. Gulch; approaches on Swede and Yukon required repair. Main appropriation spent from Glacier to Twelvemile Creek improving important cut-offs.

#### GLACIER SUMMER ROAD.

Labor protecting road during spring opening of road through driffs with teams and crew. This work retarded on account of ice seams.

A new bridge was placed across Big Gold Gulch. A new bridge was placed across Glacier Creek and road repaired from Big Gold to dredge by corduroying, ditching and placing of culverts.

General repairs from Miller Creek to Dawson

#### SUNNYDALE ROAD.

General repairs consisting of such work as ditching, placing of culverts and corduroying wet spots.

#### SIXTYMILE AND TENMILE ROADS.

Purchase of cable and labor repairing Sixtymile bridge. General repairs on Tenmile road; winter cutoff made in order to avoid overflows, and reducing distance three miles.

#### DAWSON CABLE FERRY.

Carpenters' hire repairing scows and building landing aprons, purchase of lumber, spikes, oakum, paint, brushes, oil to repair scows in spring prior to launching.

Purhcase of rope 3-8, cable sheaves, rivets, coal oil, bolts, poles, lantern and deck broom, also purchase of rowboat used as a landing boat in early spring.

Purchase of logs used as skids and booms, extra labor cutting through ice pack in spring.

Labor (2) ferrymen during the season.

Labor drilling holes in rock on West Dawson side for mooring purposes and hauling scows from river at close of season.

Compensation paid Benjamin Stone for injury received on ferry.

#### FORTYMILE BRIDGES.

### Swing Bridge.

This was re-decked with one inch lumber 183 feet long by 4 feet wide. Tightening and repairs on cables, and temporary repairs to deadmen.

#### New Bridge.

The construction of a new bridge was commenced last fall. Two diamond piers were started for foundations and a temporary structure erected consisting of bents and planking for use last winter. Some timbers were hauled for the completion of the work this spring.

Decking and general supplies for bridge were purchased.

#### FORTYMILE WINTER ROAD.

General repairs consisting of renewing and repairing small bridges and grading approaches.

A cutoff, near Fort Reliance, was made to avoid the drifting side hill trail, niggerheads levelled, and during the fall it was found necessary to cut through the ice

hummocks at several crossings owing to the rough closing of the river.

Marking out of crossings with bushes was also done.

#### OGILVIE BRIDGE ROAD.

Grading performed during spring and three culverts renewed and one new culvert built; also general repairs consisting of the cutting down of willows, ditching, filling ruts and raking off rocks.

#### OGILVIE BRIDGE REPAIRS.

Completion of dyke 160 feet long by 16 feet wide at base. Four fir posts placed under left limit approach and truss rods projecting over cylinders were sawed off.

Hand railing was repaired also.

Owing to public uneasiness in regard to stability of steel structure an inspection was made of the bridge and reported same to be in a perfectly sound condition.

During and preceding the spring break-up it was found necessary to blast the ice in order to avoid heavy jams forming.

#### BONANZA TO INDIAN ROAD.

Abnormal condition of ice required ice ditching to an extent 3,050 yards in length on Bonanza. Government of Yukon Territory and the Yukon Gold Company raised the railroad tracks at 50 Below; ditching and gravelling done, resulting in a good road.

General repairs, such as draining water off the roads, gravelling, corduroying, ditching and placing of culverts was done as fas as Indian River.

A washout on Bonanza, also one on Eldorado, caused considerable damage to road, which was repaired; also three bridges.

#### INDIAN TO STEWART.

Spring draining of roads.

Renewal of stringers, decking and railing on Indian River bridge.

Renewal of McKinnon Creek bridge; also general repairs, consisting of placing of culverts, repairing of bridges, ditching, corduroying, and considerable gravelling was also done.

#### STEWART TO PELLY.

General repairs, consisting of ditching, corduroying, grading, and right of ways to avoid spring slides, and placing of culverts, were performed and 1,753 running feet of corduroy put down.

#### EUREKA CREEK ROAD.

General repairs, corduroying, ditching, filling washouts, repairing and renewing culverts and bridges.

#### MOOSEHIDE TRAIL.

The appropriation was spent covering the season. The nature of the work was removing slides and keeping the trail in general repair. One pack trail bridge was renewed at Moosehide Creek.

#### KIRKMAN CREEK ROAD.

General repairs, such as ditching, brushing, repairing and increasing number of culverts, 1,000 running feet of corduroy and 2,000 feet of ditching was done. The road was changed in two places to avoid wet spots.

#### RIGHT FORK OF SCROGGIE.

General repairs from Walhalla to Mariposa. One mile of new road was built on Mariposa Creek.

#### HUNKER-DOMINION.

Ice ditches at Gold Bottom, 350 feet long, 3 feet wide and 3 feet deep.

Spring road drying work, one bridge with piling foundations was put in at 3 Below on Hunker, two bridges near Cash Creek, on Dominion, and a large number of culverts renewed and new ones built.

Considerable rut filling with gravel throughout the entire road was done and swamping of encroaching brush, corduroying and ditching, together with general small repairs.

Spring grading from Ogilvie Bridge to Gold Bottom.

### DOME-SULPHUR.

Spring road drying. Repaired 18 culverts, built 14 new culverts, renewed 6 culverts and repaired 4 bridges; 5,710 feet of ditching, 5,423 running feet of gravelling, considerable length of ruts filled with gravel and general repairs in minor ways.

Several roads had to be gravelled in order to obtain gravel for the main road; also grading road from Fournier's to head of Green Gulch.

#### KLONDIKE ROAD.

. Grading to Hollenbeck's during spring, and bridge across Rock Creek slough rebuilt; bridge across Leota Creek rebuilt, length 45 feet; bridge across Leota Creek slough rebuilt, length 60 feet; bridge across slough near Rock Creek repaired and Rock Creek bluff gravelled.

Considerable repair work, such as corduroying, gravelling and placing of culverts has been done. Also removing heavy slide at Flat Creek bluff.

#### UPPER STEWART DISTRICT.

General protection of roads and bridges during the spring waters.

#### MAYO TO MINTO.

Two bridges, 94 feet and 110 feet respectively, were decked, and general repairs, such as widening road, ditching and placing of culverts were done.

#### HIGHET TO JOHNSON.

General repairs, such as ditching; 22 new culverts were put in and decking two bridges, 140 feet and 52 feet respectively.

#### HAGGART CREEK.

General repair work, covering the distance of 30 miles, and considerable amount of new ditches dug; two bridges, 40 feet and 36 feet respectively, were covered, and 18 new culverts built.

#### GALENA ROAD.

General repair work for a distance of 12 miles was done, such as ditching, corduroying and putting in 16 new culverts.

#### DUNCAN CREEK ROAD.

General repairs for a distance of 24 miles, principally ditching. Eight new culverts were built.

#### MAYO BRIDGE TO MAYO LAKE ROAD.

A new road was cut from Mayo Bridge to lake, following right limit of river. Considerable amount of grading was done on this.

#### FLAT TO MINTO.

General swamping of timber along route. Protected cutoff through timber so as to avoid heavy snowdrifts in winter. Improved crossings, blasted large boulders, and erected a barn and living quarters 18x30 feet at McQuestion Crossing.

#### JENSEN TO FLAT CREEK.

General repairs along route improving hill grade and repairing soft spots.

#### PELLY TO WHITEHORSE.

The bulk of the work was done from Whitehorse to a point about seventy miles north. Four bridges and 29 culverts were built. Also repaired and cleaned out a large number of culverts. Considerable corduroying, grading and ditching was done, and one-half mile of new road built.

General minor repairs north to Yukon Crossing.

#### PELLY TO SELKIRK.

Built one new bridge across slough, 60 feet in length. One new culvert and two old ones repaired; 300 feet of corduroying done; rocks removed and ditching done.

#### KLUANE ROAD.

General repairs along entire route; four bridges renewed, of a total length of 127 feet.

#### LIVINGSTONE CREEK ROAD.

General repairs over a distance of 48 miles of trails and roads, consisting of such work as repairing bridges, culverts and cleaning out the ditches.

#### WHITEHORSE TO CARCROSS.

Money expended on Miles Canyon section. Heavy grading supported by strong crib work constitutes the highway. Considerable labor was required to finish this work.

#### GRAFTER TO VALERIE ROAD.

One bridge 120 feet long was redecked and two new culverts built. Also general repair work done, corduroy-

ing, ditching and removing rocks which were very numerous.

#### PUEBLO ROAD.

A section of this road was gravelled for a distance of 1,500 feet, and another section was covered with sandy loam a distance of 500 feet. Several culverts were repaired and some ditching done.

#### NANSEN CREEK ROAD.

Three miles of new road was built, eight and one-half miles of pack trail and twelve bridges. Considerable grading and general repair work was done.

#### CARCROSS TO VENUS ROAD.

General repairs, such as corduroying wet spots, ditching, and removing rocks was done to Conrad.

From Conrad to Venus rock slides were removed from hillside road and some grading was done.

A section of new road was built 2,172 feet long, which was practically all rock work.

#### BIG THING ROAD-SEVENMILE.

A portion of the Carcross-Venus appropriation was used on this road so as to aid a large shipment of ore.

Repairs consisted of such work as ditching, placing new culverts, widening out road and filling up deep washouts.

#### CARCROSS BRIDGE.

Repair work on this bridge was done because of disarrangement of the south approaches caused by action of the frost, the piles rising above normal height.

#### FERRIES.

The Tahkeena and Yukon ('rossing ferries were operated and used throughout the entire season.

The Pelly Crossing and Stewart Crossing ferries were operated as required.

The usual amount of pitch, tallow, oakum, rope, oil, paint, iron, etc., was forwarded for the maintenance of the ferries.

REPORT ON ROAD FROM SULPHUR JUNCTION TO BONANZA FORKS.

An examination of this road revealed the fact that the present condition of the road and the amount of travel over it do not warrant any expenditure of money.

The necessity of building a bridge and a quarter of a mile of new road around dam; also the difficulty of traversing the tailings resulting from the Yukon Gold Company's hydraulic operations should be sufficient obstacle to withdraw appropriation without going into the general grading and other repairs needed.

#### WINTER ROADS.

Glaciers were attended to on all main roads and an enormous amount of snow ploughing had to be done owing to storms.

The White Pass Route suffered considerably from drifting snow and entailed expenditures above the normal amount for taking care of same.

The ploughing out of Glacier winter trail was done with the understanding with the residents of Glacier District that they avail themselves of the opportunity to freight sufficient supplies to allow the Government to dispense with the cost of opening up the summer road in the spring.

Running of automobiles in winter also tends to increase winter expenses.

### ROAD CONTINGENCIES.

The following are items chargeable to this account:

Purchase of small boiler for general work on roads.

Repair work on sleighs, wagons and equipment, shoeing of the Government horses, etc., and purchase of spuplies which are used generally, such as horse feed, etc.

Lumber for decking railroad bridge and labor putting down same.

Repairing Ogilvie foot bridge.

Renewing bridge across Hunker at Last Chance.

Renewing bridge at "7" Pup, on Gold Bottom Creek.

Repairing Klondike City bridge.

Purchase of horse and wagon and numerous other items for districts where work was required and appropriation lacking.
