This being the first day of the First Session of the Tenth Wholly Elective Council of the Yukon Territory, pursuant to a Proclamation of the Comptroller of said Territory, dated the 8th. day of March, 1935, the Members, having previously subscribed to the oath, took their seats.

The Clerk of the Council notified the Members that he had received the following communication:

BE IT RESOLVED that a memorial of this Council be addressed to His Excellency, The Governor General in Council, on the subject of the finances of the Territory, in the form of the following telegram:

" The Hon. The Secretary of State of Canada, Ottawa.

Yukon Council now in session respectfully asks you to place before Governor General in Council the following memorial;

That Whereas the reductions which have been made in the financial grants to the Territory have brought its available funds below the minimum at which it is possible to maintain the essential public services, among which one of the most vital is care of indigents and support of hospitals which alone imperatively absorb a considerable part of the total funds:

That owing to lack of funds in past years the roads of Territory have become progressively in worse repair and are now unfit for traffic in many places;

That the Territory is now indubitably entering on new phase of mining activity in three centres, namely, the gold quartz at Carmacks, the silver quartz at Mayo and the gold placers near Dawson, which will have a part in adding to the general prosperity of Canada, but to serve which a new road at Carmacks must be built, and existing roads in the other districts put in passable condition;

WHEREFORE this Council prays that His Excellency in Council give a favorable consideration to the granting of the additional sum of \$40,000 for the essential needs of the Yukon Territory

And the question being proposed, and a debate arising, and the question being put,

PASSED in the Affirmative.
