WHEREAS the cost of living to residents of the Yukon Territory is greatly in excess of that in other parts of Canada, owing in large measure to the Territory's remoteness and the resultant high transportation charges on food, clothing and other articles classed as necessities, practically all of which have to be imported into the Territory;

AND WHEREAS the disadvantage under which the residents of the Territory labor in the respect above recited is accentuated by the fact that for many of them employment is seasonal only, long periods during each winter having to be passed while remunerative work is not available;

AND WHEREAS the exemptions and allowances provided by late amendments to the Federal Income Tax Act are such that, taken in conjunction with the rates of tax imposed, they leave the majority of residents of the Territory with insufficient resources for the support of life;

AND WHEREAS in view of the conditions above recited the new imposts by way of income tax fall with disproportionate severity upon the residents of this Territory, and place them at a serious disadvantage compared with people living in other parts of Canada;

NOW THEREFORE the Council urges that some special relief be accorded to residents of the Yukon Territory, by way of increased exemptions, or special tax allowance, to the end that this relative disadvantage may be alleviated.
