WHEREAS the presently operated transportation system between Whitehorse and Dawson has become so congested that interior points in the Yukon Territory anticipate many shortages of basic commodities at the close of navigation which will necessitate these commodities being flown in at the high rate of 15¢ per pound, which will materially increase the cost to the consumer;

AND WHEREAS a distance of only 100 miles separateds Dawson from the Mayo-Minto Road now under construction;

NOW THEREFORE, the Yukon Council, now in session, memorializes His Excellency, the Governor General in Council, that the Federal Government provide funds to complete this portion of the road to Dawson; and said Council in Session believes said road undertaking to be the most vital and needed requirement of the Yukon Territory.

The Resolution was accordingly read, and on Motion of Mr.Lee it was passed without dissenting vote.

On Motion of Mr. Lee: Ordered that he have leave to introduce the following Resolution:

That this Council now in Session recommends the construction by the Yukon Territorial Government of a pilot winter trucking road to connect the present road at Asbestos Bluff to the Stewart River Crossing, making connections with the Mayo-Minto Road, during 1949.

That this Council now in Session recommend that no Commission be set up in the Yukon Territory to investigate the transportation system within the Yukon Territory, but this Council recommends that the Commissioner of the Yukon Territory refer this matter to the Board of Transport Commissioners in Ottawa.
