# COUNCIL OF THE YUKON TERRITORY

Wednesday, 5th October, 1949, 3 o'clock p. m.

The First Session of the fifteenth wholly elected Council of the Yukon Territory was opened at 3 p. m., Wednesday, October 5th, 1949, pursuant to proclamation of the Commissioner dated 29th August, 1949.

Mr. J. E. Gibben, K. C., Commissioner for the Yukon
Territory, indicated in his opening address that it was his
pleasurable duty to welcome the members elect, and especially
Mr. E. J. Corp, Member for Mayo, who had for many years rendered
good and faithful service, more particularly in view of his
being elected by acclamation. To Mr. Lee, Member for Whitehorse
and Mr. Lelievre, Member for Dawson, the Commissioner extended
a sincere welcome and stated how both those members had to
contest their right to represent the electorate, which indicated
a healthy interest in matters of public concern, where public
views and dissensions were thoroughly rired, especially where
there were no party lines drawn: The matters of state were in
this way well publicized.

The Commissioner stated that the Administration was happy to have Mr. R. G. Lee, who for many years had rendered service both as a Member for Mayo and Whitehorse sitting in the Council. Mr. Lelievre was present for the first time as a Member of Council but it was not, however, the first occasion that he had assumed the responsibility of administration as he had sat on many committees on law amendment and we were looking forward to receiving real assistance from him.

The Commissioner, before indicating the business that would be presented for consideration of the Council, had each member of the Council take the Oath of Office and Oath of Allegiance. That is:

Mr. Ernest J. Corp, Miner, Member for Mayo
Mr. R. Gordon Lee, Merchant, Member for Whitehorse
Mr. C. J. Lelievre, Manager, Member for Dawson

Mr. Gibben then outlined to the members of the Council
the importance of the legislation and other matters of business
that would be submitted for consideration, and expressed his
belief that careful consideration would be given to each matter
as it was presented. It was indicated from a perusal of past
sessional papers that the business coming before the Council
had taken on added importance from year to year with the
development of the Territory along provincial lines and the
more complex problems of administration arising out of the
broader view held by the authorities of the Federal Government
and the Yukon toward the development of the North.

It may have been that lack of funds available to Council in the past years accounted for the slower development but nevertheless the present Council carried a heavy responsibility to the people of the Territory and Mr. Gibben was confident that this responsibility would be discharged at the present session.

The Administration had come to rely upon the assistance given by the people's representatives, and would continue to do so, not only during sessions, but between sessions would continue to consult each of the members in matters of policy and administration.

Mr. Gibben stated that one of the more important pieces of legislation before Council was the Municipal and Taxation Ordinance, which was to implement our covenant with the Federal Government, in accord with the suggestion made by the Deputy Minister, wherein our tax structure was to be remodelled and also providing for Municipal Government development within the Territory.

Mr. Gibben stated that at the moment he did not find anything in the Ordinance that would add additional burden to any member of the Territory.

Mr. Gibben added that there were other ordinances of less importance which the members would consider, such as the "Bulk Sales Ordinance" and "Assignment of Book Debts Ordinance" which were primarily to unify this type of legislation with that of the other provinces. A general effort was being made throughout Canada to have the legislation of each of the provinces unified for better administration.

The Gasoline and Diesel Oil Ordinance was again being submitted at the request of the Federal Government.

With this outline before the members, the Commissioner stated he rested assured that the deliberations of Council would be productive not only for our present time but as a foundation for future extension.

The Commissioner then withdrew from Council.

That Legislation be prepared to be submitted for consideration of Council at its next session, bringing present Yukon Territory Workmen's Compensation into conformity with that of the other provinces as to benefits and administration.

That in the above study Legislation also be considered relative to providing hospital insurance plan similar to that of the Blue Cross or any other plan which would provide similar benefits, and if considered possible provide for a collection and clearing house to facilitate the obtaining of participation by small employers of labour in such a plan.

2. Petition of the Bear Creek Community re Dawson Public School.

The Council recommends for consideration of the Administration:

- 1. That a safe and adequate fire escape be provided for exit of children from the second floor at an early date.
- 2. That the floors of the school be either resurfaced or refloored.
- 3. That a hot water system be installed for the purpose of providing hot water for use of children who are forced to remain at school the whole day by reason of distance to travel, etc.
- 4. That facilities be provided for the preparation of hot lunches under supervision for all children remaining in school during the lunch hour.

The Council recommends that the Commissioner do prepare an Ordinance to regulate the sale of spirituous liquor for beverages in cocktail lounges, in which provision will be made for:

Municipal districts having a population of between 50 and 500 one license

municipal districts having a population of between 500 and 1500 two licenses

municipal districts having a population of between 1500 and 3000 three licenses

municipal districts having a population of between 3000 and 5000 four licenses

Territory's legislation up to a standard comparable with the rest

SO BE IT RESOLVED that the Yukon Territorial Administration prepare for presentation to the Yukon Council at its next session an ordinance dealing with health and sanitary control that will be applicable generally in so far that existing legislation is consolidated and be it further resolved

that the draft submitted to this Council of proposed legislation dealing with the sanitary control of industrial camps be considered in the drawing up of the above-mentioned legislation.

Letter re St. Mary's School.

The Council directed the Territorial Treasurer to write the Sisters outlining that such grant was made on a basis of a fixed payment per pupil, and not on the basis of one or more teachers. Therefore, arrangements for payment as requested could not be complied with by the Council.

Petition of Yukon Civil Servants was considered.

The Council recommends that the administration take under consideration the study of a complete Civil Service Ordinance wherein would be provided provision for: establishing of schedule of salaries, holiday leave, sick leave, etc. comparable with other provinces, and the content of this Petition be given full consideration when drafting such legislation to be presented to Council at its next session.

The Council recommends that the administration prepare for consideration of the Council at its next session legislation relative to compulsory holidays comparable to a draft ordinance filed herewith.

This Council respectfully requests that the Commissioner memorialize the Federal Government to consider granting assistance to the Yukon Territory under provision of the National Health Programme on the same basis as is applicable to the other provinces of the Dominion.

WhEREAS there has been a very sharp increase in the cost of living since the end of the war!

AND WHEREAS this increase has imposed great hardships upon people with low, fixed incomes)

AND WHEREAS those in receipt of the old age pension have been given no pension increase commensurate with the increased cost of living;

AND WHEREAS the means test not only prevents some recipients from receiving the full amount of the pension, but also prevents old age pensioners in general from supplementing their pension to any appreciable extent by outside earnings;

THEREFORE we the Territorial Council of the Yukon Territory appeal to the Government of the Dominion of Canada to increase the exemption from \$120.00 to \$360.00 per annum under means test provided under the Old Age Pensions Act at the earliest possible moment.

It is therefore suggested that the amounts should be approximately four hundred dollars per annum and that further technical assistance be afforded similar to that provided by the Province of British Columbia, through the services of a field mining engineer or geologist.

And the Territorial Council further recommends that consideration be given to the amending of fees applicable under section 40 of the Yukon Placer Act.
