WEDNESDAY October 25,1950 3' Oclock P.M.

The third session of the fifteenth wholly elected council of the Yukon Territory was opened at 3 P.M. Wednesday October 26th, 1950. Fursuant to Proclamation of the Commissioner dated September 23rd,1950.

Members of the Legislative Council:-

It gives me great pleasure to welcome you to the Third Session of the fifteenth Council of the Yukon Territory.

As a new comer to this Territory I may take a moment to say something of my impressions gained from a hurried visit to the principal parts of the Territory and the chief centres of population. I came direct to Dawson by air and after a few days here went first to Mayo Landing and from there to the mining area adjacent to Keno Hill where a brief visit was spent at the Llsa Camp and mill. From there we went to old eamp at Keno Hill and on to Mayo Landing to the Territorial Offices there, the school, the hospital and other points. From there I went to Whitehorse and spent a week in the Southern part of the Territory reaching almost to White River in the North West and to Teslin in the South East. Heturn was made to Dawson by way of the Yukon River, a somewhat tedious but instructive trip which enabled me to visit the settlements along that route. In the immediate vicinity of Dawson I have made trips over all the roads within about a fifty mile radius, and have also been shown over the hydro electric power plant and the dredling operations of the Yukom Consolidated Gold Corporation by the kindness of the officers of that Corporation.

All this was very hurried and was undertaken so that before your Session I might acquire the bare minimum of acquaintance with the Territory and its problems which might enable me to have an intelligent apprec- 1 iation of the problems you would meet to discuss and . deal with. If it is of interest to you to hear it permit me to say that, while I have been made aware of the former great days and the intensely interesting history of the Yukon, I am more concerned with and more enthusiastic about its future development. There are developments under way which I am . confident will establish and maintain here a prosperity quite as great as that of the romantic past and will give a sounder basis for the maintenance of a population as great in numbers, securely based and enjoying most of the amenities of modern civilized life.

You will in your present Session be asked to consider the following measures: (the order in which they are mentioned is accidental and has no significance):

- (1) A Revised and up-to-date- School Ordinance, better fitting our local educational set-up;
- (2) An Amendment to the Gasoline Tax Ordinance,

 designed to exempt from taxation vehicles

 operated on behalf of any Department of the

 Government of Canada, United States of America,

 and the Territorial Government;
- (3) An Amendment to the Benevolent Societies
 Ordinance, which corrects errors in drafting
 of this Ordinance as originally passed by
 Council,

- (4) Three Amendments to the Municipal Ordinance:
 - (a) A clarification of election procedure in Municipal Elections;
 - (b) The alteration of the description of whitehorse to include a larger area;
 - (c) To exempt from taxation areas within the Municipality set aside for recreational purposes.

You may also be asked to consider a further Amendment to this Ordinance dealing with the Territorial Purposes levy.

- (5) An Amendment to the Game Ordinance designed to remove a conflict between it and the Migratory Birds Convention Act.
 - (6) An Amendment to the Mining Safety Ordinance which makes offences under this Ordinance triable by Police Magistrates and Justices of the peace.
- (7) An Amendment to the Judicature Ordinance giving Justices of the Peace jurisdiction in cocrtain small debt actions.
 - (8) A new Crown Grant Tax Ordinance will be introduced for consideration with a view to clarifying and ratifying procedures under the old Crown Grant Tax Ordinance.
- (9) An Amendment to the Old Age Pension Ordinance made necessary by removal of the Stipendiary Magistrate from this area. The Stipendiary Magistrate was ex-officio a member of the Board and provision is now made to have a Member appointed by the Commissioner.
- (10) An Ordinance authorizing an Agreement between the Dapartment of Resources and Development and the Territorial Government in connection

with the construction of the Whitehorse Public School.

(11) The Holiday Ordinance, deferred at the request of Council during its Spring Session, will be re-introduced at this session.

Two Ordinances will be repealed, namely,

- (1) The Sidewalk Ordinance, being Chapter 3 of the Ordinances Yukon Territory, 1944, and
- (2) The Bridge Ordinance, being Chapter 11 of the Consolidated Ordinances Yukon Territory, 1914.

These Ordinances are no longer applicable to local conditions.

I feel sure you will bring to your deliberations a high sense of your responsibilities and an honest determination to find sound, practical solutions for the problems confronting us.

May I leave you then with the assurance that any assistance you may request from or through Mr. Wylie or Miss MacDonald will be immediately and gladly given.

Lir E.J. Corp, Speaker, spoke in reply to the Commissioners Address indicating the pleasure of Council in assuming the responsibility placed upon the members by the Commissioner and gave assurance that each member would discharge to the best of his ability the grave responsibility devolving upon him by virtue of his office.

Mr. Corp also indicated that it would be the pleasure, and desire of the Council to assist the Commissioner and Administration in any way possible.

Upon retirement of the Commissioner, Mr. Speaker assumed the chair:

The Territorial Treasurer submitted for consideration of the committee the matter of establishing a basis for carrying into effect the setting of the Mill rate provided under the provision of the Municipal Taxation Ordinance which would be acceptable to the Committees representing the Cities of Whitehorse and Dawson. After full consideration the Committees of the whole agreed that a rate of 10 mills be established for the current tax year. In addition the grants as passed by the Council of \$\psi_30,000.00\$ for the City of Dawson and \$\psi_25,000.00\$ for the City of whitehorse be the total grants for the 1950-51 Fiscal year.

Moved by Mr. R.G.Lee that Council adjourn until 2 F.M.

Council resumed at 2 P.M. as a committee of the whole.

Matters pertaining to the Finance of the Territory were under consideration.

Mr. Hulland Superintendent of Schools attended before the Committee and presented an outline of the needs of the schools, and the matter of salary adjustments for teachers.

The Committee accepted Mr. Hullands outline and assured him that full consideration would be given of his problems.

The Board of Management of St. Faul's Hostel attended the Committee to discuss the problem of operation of this institution in veiw of the low number of children now assigned its care. Mr. L.H. Phinney indicated that a minimum of 21 children was required if the present rate of \$\pi 1.90\$ per day was to be adequate.

The Council made enquiry as to the running of the institution and the cause of the unfortunate incidents that had occured during the present year.

Ar. Phinney indicated to council that in the opinion of the Board and himself, that though it was an unfortunate incident the responsibility could not entirely be laid upon the management of the institution. From evidence coming before himself as stipendiary Magistrate he was satisfied that it was an out growth of General Conditions affecting the youth of the Community.

The suggestion was made that due to the problems of Child Frotection that time was fast approaching when the Council would be required to establish an institution for Child care for all ages of children, and it might well be the time now, when some provision should be made towards gaining this end.

Mr. Corp expressed the appreciation of the Council for the pertitent information given by the Board, and assured them that full consideration would be given.

The following members of the City Council and the Medical Health Officer for City of Dawson attended Council to Fresent matters effecting the Cities Administration.

Councilor C.V.Mellor Councilor L.G.Cole
Dr. B. Duncan

Mayor H .W. Firth informed Council that there were a number of problems the delegation wished to discuss the most important being the policy of T. B treatment and financial provisions made available by the Government. Dr. Duncan was requested to place before Council the recommendations formulated at a meeting of the local T. B. Association. It was intimated that the local board considered that the Ordinance passed at last session was likely to prove difficult from an administration point of view. The question was asked as to the view held by the Medical Personnel in the Territory relative to the treatment of patients in the Territory. Dr. Duncan speaking for himself and other Medical specialist in the T. B. field advised strongly against sanatoria being established due to the lack of sunlight and dietary deficiencies which increased the cost tremendously and retarded the recouvery of the patient. Dr. Duncan suggested that every source of

availability of beds should be investigated, and only when it was ascertained that sufficient beds could not be obtained should the Government proceed to provide hospital accommodation in the Yukon.

Dr, Duncan suggested that in his opinion it was advisable that the School be closed for Junior Grades say from one to six on the first of June each year and either return early in August or remain closed until regular opening in September. The reason being that the benefits derived from the sun were much greater in June than any other month.

Dr, Duncan recommended that a Me<u>dical</u> and De<u>ntal</u> E<u>xamination</u> by-annually for all school children was an essential service in the districts.

The members of the City Council forceably concurred in the recommendations voiced by Dr. Duncan and requested that the Territorial Council give full consideration to implementing them at the earliest possible date.

Alderman Mellor spoke at length on the matter of financial assistance to the City.

Alderman Cole requested that the Territorial Council reconsider the matter of repeal of the Territorial Public Purposes Levy, indicating that it was an unjust tax, and placed the City elected representatives in a very embarrassing position. Further discussion was carried on by the other members of the delegation.

Mr. Corp indicated that all matters discussed would be given full consideration of the Council during the present session.

To negotiate basis of Insruance Coverage and Civil Service Pensions

The Commissioner visited the Council and discussion of what progress relative to St. Marys Hospital building, and Whitehorse Public School had been made during the imterim period May to present date. The Commissioner indicated that some progress had been made, but due to unforseen circumstance in connection with both projects, unavoidable delays had been exexperienced. It was considered that new plans would likely be submitted by the Federal Authorities, which would have to be fully considered in veiw of the work undertaken during the period by the Sisters of St.Anne.

The Commissioner also indicated that in connection with Whitehorse School, that due to a survey made by Col. Jones of the North West Highway system of Edmonton it would appear that further negotiations would have to be entered into, though it had been intimated that the

plans and calling of Tenders would be completed before the end of February, 1951.

Re Elsa and Duncan Creek Roads-Mayo Recommended that the Elsa and Duncan Creek Roads both be kept open until it is possible to ascertain which of the two roads should be kept open during the winter months, the Administration keeping in mind the necessity of declaring at an early date which road would be considered the public Road to _Keno Hill.

Dawson- Quarts Creek Road was considered, it being recommended by Mr. Harvey that this road be closed for Winter traffic as from September 1951

The Council endorsed Mr. Harvey's recommendation.

Costs relative to the Dawson Mayo extension were submitted to Council.

Recommended that the Administration negotiate with Federal Government of Canada for assistance in developing this road as a secondary road.

Other matters relative to the work of the Department were discussed in general, and the Council expressed appreciation to Mr. Harvey for his outline covering operations.

By appointment Mr. A. H. Gibson and Mr. N. V. K. Wylie visited Council.

Application of Hyde and Morrison for franchise to operate a telephone service between Mayo and Whitehorse was discussed.

Decided that the Commissioner make further enquiry re possibility of Canadian National Telegraph.

Service providing this service before any franchise granted. The Commissioner to ascertain the bona fides of the applicants.

Mr. Lee requested information relative to issue of banquet permits under provision of the Liquor Ordinance, indicating that information had been given him that permits were being issued contrary to the spirit and intent of the provisions.

Members of the Legislative Council:

You have now concluded your labours for this Session. It has been stimulating to see with what zest you have entered into the work before you, and the patience and care you have given to the deliberations on which you were engaged.

Your work has been accomplished in the briefest space of time, but has not been hasty. It was very evident that you put personal concerns aside and gave your whole time to the matters in hand. It was evident also how valuable in your deliberations were the knowledge and experience which each Member had gained in his own long residence in the Territory and was able to draw upon.

I must express to you my tranks for the painstaking concern you have shown for the interests of the people of the Territory whom you: represent.

Their confidence in you would appear to be well justified.

There are a good many questions to be faced in the future, some of which will require attention and decision in the near future, and I trust you will continue in the coming months to keep yourselves alert to these questions, and that you will, as speedily as possible, bring to our notice any new matters which may require attention.
