# Whitehorse, Yukon Territory Thursday, November 8th,1956

Mr. Speaker, and Members of the Yukon Council:

I am pleased to be again present and welcome you to this hird Session of the Seventeenth Wholly Elective Council of the Yukon Territory.

Since Council last met the Government has carried out the program of activities for the period concerned with the funds then provided and with the exception of the Liquor Store at Watson Lake, which has had to be postponed until next year because of the delay in obtaining grant of the necessary lands, all items of construction have been completed and those of maintenance carried out on the government seasonal basis.

Revenues are conforming closely to those estimated for the period and fiscal year. Government and private construction activities in process or planned for 1957-1958 indicate no drop in revenues for that year and, therefore, the current financial picture of the Territory, as a whole, can be painted in fairly bright colours. Mining development remains in the prospective category and until this stage is passed and successive steps to operation achieved we can look to no marked increase in population and economic expansion.

Federally financed construction projects in the Territory consisting of the new hospital, bridges, housing, etc., have progressed according to plan and work on the hydro-electric power project of the Northern Canada Power Commission in the vicinity of Whitehorse will be commenced at once. Utilizing the warm water wells the sewer and water distribution system in the City of Whitehorse as presently completed is expected to be in operation within a few days. Construction work on the project has now ceased until next spring when the reservoir and balance of the work to be done can be carried through to completion. The tentative date for this is September, 1957.

It is anticipated that the new Territorial Hospital at Mayo will be opened next month even though all planned equipment and furnishings have not been delivered at that time. This hospital, when completed and equipped, will be one of the finest small institutions of its type anywhere in Canada.

## Reply to Commissioner's Opening Address

# Mr. V. C. Mellor, Esquire

Whitehorse, Yukon Territory Friday, November 9th, 1956.

Mr. Speaker:

I wish to draw your attention to the substantial increase of mining development and exploration in the Dawson District, and also the determined effort to establish the Oil Industry in the Yukon Territory.

Results from this activity are beginning to bear fruit in reference to the economy of my District.

May I point out that I am not predicting anything such as "boom", which usually has repercussions a year or two later, with sometimes more failures than success. The activity is due to a conservative approach by four major Mining Companies.

Heretofore, the Dawson District has been a gold producing camp for fifty years, but now I am glad to say that we can look forward to the prospecting and development of asbestos, copper, lead and silver deposits, and the final phase of drilling for oil.

- 1. The Yukon Consolidated Gold Corporation has maintained its steady production of placer gold, the value of which I have pointed out to Council on previous occasions. Placer gold represents the only mineral production in the district at the present time. During the past year, the Gold Corporation has taken an active interest in other minerals. It has diamond drilled a copper prospect on Gold Bottom, 20 miles east of Dawson City, and has done a considerable amount of trenching on two asbestos prospects.
- 2. The Conwest Exploration Company, have developed a large tonnage of asbestos at Cassiar Creek. This doosit must not be confused with the Cassiar Asbestos mine at Cassiar, B.C., because, as a matter of coincidence, the creek north of Dawson City was named Cassiar in the early days.
- 3. The Asbestos Corporation, one of the major companies in the asbestos field carried out extensive exploration work, aided by helicopters during the summer field season and is now conducting an airborne geophysical survey.
- 4. The Gaymont Exploration Company has taken an active interest in the District's mineral possibilities and has optioned an asbestos prospect.

The mining developments and activities which I have spoken about, the hold-up of transportation, waiting in the winter for ice bridges, and ferry service in the spring should prove that permanent bridges over the three rivers, namely: Yukon, Pelly and Stewart are an essential part in the development of the country.

Regarding Resources, I would like to point out the potentialities in the Dawson District of the  $^{\rm T}$ ourist Trade which would be beneficial to the revenues of the Territorial Government. During the season of 1955, we had 840 visitors at our Museum. From January to October 15th, 1956, we had 2,175 visitors which shows that the Tourist Trade is increasing. The City of Dawson, without aid from the Territorial Government, has provided a free Tourist Camp with water, accommodations and fishing, and is advertised over K.F.A.R. Radio Station, Fairbanks, Alaska and K.O.A. Radio Station, Denver Colorado, U.S.A. The curator of the museum in Dawson being Mrs. E. Gaundroue.

Concerning the ferry at Dawson, an extra shift on the ferry is desirable the cost of which would be off-set by an increase in tourist traffic. On many occasions tourists who wished to visit Dawson have decided not to do so, due to the fact that they could not reach the last ferry at Dawson by 6:00 P.M., and therefore, have returned via the Alaska Highway. I would suggest that the ferry service be revised as soon as possible.

The wild life of the Territory: The wolf is quite a problem which must be studied and action taken to control this predator. I have had representations made from trappers and the public in my district for reinstatement of the "olf Bounty, which I understand meets with great success with our neighbors of the Territory of Alaska.

I would also draw to your attention the regulations concerning the shooting of moose; At the present time a hunter can legally kill one bull. I am of the opinion there should be one restricted season open for the taking of cows. During the present hunting season, we have had big game non-resident hunters for the first time in my District, one, the noted Jim Bond, who hunted in the Blackstone District.

Mr. Speaker: I will ask you and my fellow colleagues for your kind and sympathetic consideration during any legislative matters that may come before you concerning the Dawson Electoral District.

Mr. Speaker:

I have just returned from Watson Lake, and, for Council's edification, I would like them to see a few pictures I took of the new Community Hall which is under construction. I think it has a bearing on the welfare tax which has come up before the Council on several occasions.

The Carcross Cummunity Club has proceeded with their Community Center. Unfortunately I have no pictures of this building with me.

The Watson Lake Community Club has built a curling rink with three sheets of ice and a club room 50 feet square. A building worth somewhere around \$30,000.00 and one which will serve as a center for their community for many years. The financing of this project was done principally by Mr. Lund of Watson Lake Hotel and Mr. Jack Ward of 'Jack and Mac's', two business men of the area and I think it is a good example of the co-operation which business men give to the community work in the Yukon. I bring this up because business men have been under criticism on several occasions by people who should know better.

The Carcross Community Club is constructed now and they are busy putting in a curling rink. It is these small community clubs, I believe, which will add a great deal to our life and the help given by the tax on liquor is of utmost importance to them. Thank you.

# BRIEF

This brief is being submitted in the firm belief that it is in the interest and advancement of the Yukon Territory.

The subject matter in this brief is taken from the studied opinions from men interested in mining, roads, and to-morrow.

## Mining

Setting aside placer gold mining, which is the basic industry at the moment, there has been considerable activity in the search for other minerals, which has resulted in more than a little success. The showing of asbestos at the Yukon Cassiar Creek is considered good. The diamond drilling results for copper from Gold Bottom are not known. At the moment, diamond drilling is in progress half-way up to the Dome behind Dawson City, to determine the extent of the asbestos showing there.

## <u>0il</u>

Peele Plateau Exploration Ltd. has already done a preliminary amount of work determining the extent of the oil deposit in the Eagle Plain area.

The copper prospects in the Chapman Lake and Hart River area is, to put it mildly, promising.

Considering all this mining activity with its promising development, the next phase to consider is Road Construction.

# Roads:

Transportation is the mainspring in the opening of new areas. More than one route has been considered and this brief is in support of the Eagle Plain road which starts at Flat Creek and following the North Fork of the Klondike River over the divide to the Eagle Plains area.

In supporting this road, the brief is of the opinion, that the economy of not only the Dawson area, but of the mining activities concerned, would be greatly increased, if the road from Flat Creek to Dawson would be rebuilt to eliminate the winding nature of it, so that the travelling time could be reduced by half of what it is now, so that supplies and service from Dawson could be much faster, easier and cheaper.

Peele Plateau Exploration Co. Ltd. may seek Governmental aid in building the road from Flat Creek. If Peele Plateau Exploration Co. Ltd. seeks aid, this brief feels that the Government should give every consideration to it and, to repeat, the road from Dawson to Flat Creek should be straightened out.

In addition to road development, it must be borne in mind that the closest proximity to the Alaska Highway, oil pipe line, is a governing factor as to location of both roads and pipeline. This brief points out that the Dawson area is obviously the closest to the Alaska Highway and the deep sea port of Valdez, Alaska for world export.

# RESOLUTION

WHEREAS in or about the year 1951 the City of Whitehorse caused plans and estimates to be prepared for a Water and Sewer System to serve the said City;

A N D W H E R E A S the estimated cost of such a System was approximately Seven Hundred Fifty Thousand (\$750,000.00) Dollars;

A N D W H E R E A S the ratepayers of the City subsequently approved a By-law authorizing the City to borrow the sum of One Million (\$1,000,000.00) Dollars for the purposes of installing the said System;

A N D W H E R E A S subsequently it was decided by the Department of Northern Affairs and National Resources to develop the easterly side of the Yukon River opposite the City of Whitehorse, such development to include a joint hospital, bridge, and residential sub-division complete with water and sewer;

A N D W H E R E A S the estimated cost of the water and sewer installation in the new sub-division was Seven Hundred Thousand (\$700,000.00) Dollars such sum to be assumed by the Territorial Government and recovered by the sale of Lots in the new sub-division;

A N D W H E R E A S it was considered expedient to let one joint contract for the Water and Sewer Systems for the City and the new sub-division;

A N D W H E R E A S the City of Whitehorse appointed the Commissioner of the Yukon Territory its Agent to contract for and supervise the installation of the City's portion of the joint contract;

A N D W H E R E A S the said Commissioner as Agent for the City and as representative of the Department of Northern Affairs and National Resources entered into contracts for the said water and sewer installations;

A N D W H E R E A S the capital cost to the City chargeable to the ratepayers for the said System was to be Ten Seventeenths (10/17) of the total cost but in no event to exceed One Million (\$1,000,000.00) Dollars;

A N D W H E R E A S subsequent to the foregoing Agreement the design of the joint Water and Sewer System was altered to provide a system capable of serving the needs of Twenty Thousand (20,000) people such alterations being made without the knowledge or consent of the City or the Territorial Council;

A N D W H E R E A S the moneys provided for by the City and the Territorial Government, namely One Million Seven Hundred Thousand (\$1,700,000.00) Dollars have been expended prior to the completion of the installation of the said joint System as so altered;

A N D W H E R E A S it is estimated that the sum of Four Hundred Fifty Thousand (\$450,000.00) Dollars will be required to complete the System as presently designed;

A N D W H E R E A S the City is now facing substantial additional operating costs because of the present design of the said System which it will become the City's responsibility to maintain following the completion of the System;

AND WHEREAS neither the City nor the Territorial Government are in a financial position to assume the aforesaid additional capital costs;

NOW THEREFORE BE IT RESOLVED that this the Third Session of the 17th Cholly Elective Council of the Yukon Territory duly assembled, conscious of the present inability of the City of Whitehorse to assume further financial responsibilities in connection with the financing of the sewer and water construction project, and desirous of assisting in the completion of same, respectfully request the

Government of Canada ot advance, without interest, the sum of Four Hundred Fifty Thousand (\$450,000.00) Dollars or any lesser sum required to complete this project. Such advance to be recorded on the books of the Government of Canada as a contingent liability of the Government of Yukon Territory until such time as the population of the City of Whitehorse shall have reached Ten Thousand (10,000) people, being one-half the population for which the aforesaid Water and Sewer System has been designed. At which time it shall be allocated in the same proportions as the original loan of One Million Seven Hundred Thousand (\$1,700,000.00) Dollars, namely: Ten Seventeenths (10/17) to be loaned to the City of Whitehorse at a rate of interest and period of amortization then to be decided. Seven Seventeenth (7/17) to be loaned to the Government of the Yukon Territory at a rate of interest and period of amortization then to be decided.

## REFERENCE TO COUNCIL

Mr. Speaker and Members of Council:

In addition to the Supplementary Estimates placed before you, the following items of 1956-57 expenditures have been discussed with and approved by you:

- 1. A grant up to \$10,000.00 to United Keno Hill Mines Ltd. for the winter maintenance of the new Elsa-Keno road to be accounted for by records maintained by the company and audited by the Territory.
- 2. An additional sum of \$\pi 2,000.00\$, if required to cover winter maintenance of the Calumet-Keno road by Mackeno Mines Ltd., subject to audit of records by the Territory.

# RESOLUTION

WHEREAS it has become apparent that a great need exists for the presence in Whitehorse of a Dominion Land Surveyor to survey and subdivide various lands within the Territory in order to satisfy requirements of various Government Departments and further to facilitate the disposal of land owned by private persons;

AND WHEREAS the season is too short to allow a Dominion Land Surveyor in private practice to make an adequate living;

AND WHEREAS the program of work for Dominion Land Surveyors in the employ of the Department of Mines and Technical Surveys is at least two years behind in the Yukon Territory;

THEREFORE BE IT RESOLVED by this Council that the

Minister of Mines and Technical Surveys be respectfully approached

to give full consideration to the employment of an additional Dominion

Land Surveyor to be stationed in season at Whitehorse; such Dominion

Land Surveyor to have the power to accept contracts from private

persons for the purpose of surveying their lands as well as carry

out such additional Government surveys as are necessary to ensure

his full employment;

IT IS FURTHER RESOLVED that the Minister of Mines and Technical Surveys consider a scheme whereby the income received by the Dominion Land Surveyor in the fulfillment of private contracts of survey could be deposited with the Receiver General of Canada, but the terms of his employment be such that priority be given to such contracts as from time to time may be received by the said Dominion Land Surveyor from private persons.

IT IS FURTHER RESOLVED that the Commissioner be respectfully requested to forward this resolution to the Minister of Mines and Technical Surveys at his earliest convenience.
