Question Re Administration Building at Haines Junction

Mrs. Watson: Mr. Speaker, I have a question for the Commissioner this morning. And it regarding the administration building at Haines Junction that was built at an approximate cost of one million dollars. The building is now being occupied by the Game Branch and the Library Branch. The Liquor store has not moved into the building because apparently the original design of the building, did not accommodate the scissor lift that was purchased to be used for the dispensation of beer. Also the fire hall, the fire department has not moved in because the fire doors do not operate. It takes three men to open a fire door. My question Mr. Commissioner is for the past two weeks we've had a crew from the Territorial Government out working on the administration building in the liquor store portion of it. Tearing down walls and doors, doing extensive renovations in order to accommodate the scissor lift. I don't know what they're doing to the doors, hopefully they'll do something to them so one man can open the fire hall doors. My question is why were not — why did the original design of the building, not accommodate the lift that the Government purchased, and my second part of the question is how much extra will the cost of these renovations be, and the third question is who will be bearing these costs. Will it be the Territorial Government or the contractor? Thank you Mr. Speaker.

Mr. Speaker: Mr. Commissioner?

The Commissioner: Mr. Speaker, it would appear that there's several problems that are involved here, and I wonder if the Honourable Member would be kind enough to allow me time to prepare a written answer to the question.

Mr. Speaker: The Honourable Member from Whitehorse Riverdale?

Question re Electrical Franchise

Mr. Lengerke: Mr. Speaker, I have a question this morning for the Commissioner. It's with respect to the electrical franchise, and as I understand it, the City of Whitehorse is required to award a franchise under the Electrical Utilities Ordinance, and of course as we all know, they haven't done this as yet, and my question to you, sir, this morning is, if they don't award a franchise, are they subject to legal implications or what do we say, reprimand from this government for not doing so, or should they be awarding an interim licence or what kind of action should they take at this time with respect to that legislation that they are bound by?

Mr. Speaker: Mr. Commissioner?

Mr. Commissioner: Well, Mr. Speaker, I would be very hopeful that the days of the senior government reprimanding junior governments is over with, but if

the Honourable Member would be good enough to give me an opportunity to examine the particular question that he has raised, why I'll do my very best to come up with an answer in connection with it.

Mr. Lengerke: Okay.

Mr. Speaker: Are there any further questions? We will then proceed to Public Bills.

SESSIONAL PAPER NO.1 1976 FIRST SESSION

AMENDMENTS TO LAND USE REGULATIONS

Mr. Speaker,
Members of the Assembly:

I have recently received a response from the Minister of Indian and Northern Affairs to the Assembly's motion respecting revisions to the Territorial Land Use Regulations which was passed at the 1975 fall session. The Minister advises me that he intends to proceed with the publication of the amendments (as written October 20, 1975) in the Canada Gazette. The detailed amendments proposed by the Assembly will be given further consideration together with the comments received from other concerned groups within a six week time period following the date of publication as provided in Section 19 of the Territorial Land Use Act.

The Minister offered specific comments on aspects of the Assembly's motion, which I include here for the Assembly's information:

Motion

"That having respect to the regional differences between the two territories, the Yukon be considered a land management area separate and apart from the Northwest Territories."

Comment

The revisions as currently written provide for two Land Management Zones, one for the Yukon and one for the North West Territories. This is an administrative arrangement and should not be construed as a recognition of differing levels of environmental sensitivity between the two Territories.

Motion

"That the Yukon be divided into Arctic and Non-Arctic Yukon sub-zones, with a boundary established at 65 degrees, 45 minutes north latitude."

Comment

I seriously question whether the Yukon can be effectively divided into "arctic" and non-arctic" zones. The boundary seems to conform to the northern limit of present day mineral exploration activity in the Yukon

and as such has no basis in terms of terrain sensitivity, wildlife populations or habitat, or potential conflict with the interests of native communities. There are many areas in the so-called "arctic" zone where the potential for environmental disturbance at certain times of the year is small and where a Class 'B' permit would be appropriate for most land use operations. Conversely, there are many areas in the "non-arctic" (sic) where the extended time frame associated with a Class 'A' permit would be required, for the thorough consideration of some permit applications. The revised Regulations are designed to accommodate the broad spectrum of terrain types and renewable resources which characterizes the Yukon, and the variety of land use operations which take place at various times of the year. Seen in this light, any simple concept of zonation would have very little meaning.

Motion

"That separate Land Use Regulations be applied to each sub-zone."

"That proposed Land Use Regulations (October 1975) apply to the Arctic Yukon sub-zone only."

"That in respect of the non-arctic sub-zone the proposed Regulations be amended as recommended in Schedule 1 of this motion."

Comment

The need for greater flexibility in the application of the Land Use Regulations has been taken into account in the proposed revisions. The provision of two broadly defined types of permits should dispell the need for yet another, more complex and inherently less flexible regulatory framework. It is unfortunate that there was little discussion of the merits of the two permit system during the Assembly's deliberation on the subject. As you know, the Class 'B' permit, which would apply to most mining operations, can be, and usually would be, issued immediately, and the Class 'A' permit can be issued within a few days, if circumstances allow as is presently the case in the administration of the current Regulations.
