This being the first day of the first meeting of the 28th wholly-elected Legislative Assembly of Yukon for the dispatch of business and the Members, having previously been duly sworn in, having taken their seats in the House, the Clerk of the Legislative Assembly read the Proclamation as follows:

TO ALL TO WHOM these presents shall come of whom the same may in any wise concern

GREETINGS

A PROCLAMATION

KNOW YE THAT under and by virtue of the power and authority vested in the Commissioner of the Yukon Territory, the Assembly of the said Territory is summoned to meet for dispatch of business in the Yukon Legislative Assembly Chambers, Territorial Administration Building, Whitehorse, Yukon Territory, on Monday, the fourteenth day of December, A.D., 1992 at the hour of three o'clock in the afternoon.

ALL OF WHICH all persons concerned are required to take notice and to govern themselves accordingly.

The Commissioner, the Hon. Ken McKinnon, entered the Chamber and took the Chair.

The Clerk of the Legislative Assembly then stated:

"I am commanded by the Commissioner, in his capacity as Lieutenant-Governor, to state that he does not see fit to declare the causes of the summoning of the present Assembly of this Territory until a Speaker of this Assembly shall have been chosen according to law, but today at a subsequent hour he will declare the causes of the calling of this Assembly."

The Commissioner then retired from the Chamber.

ELECTION OF SPEAKER

The Clerk addressed the House:

"Honourable Members, nominations are invited for the office of Speaker of this Assembly."

It was moved by the Hon. Mr. Ostashek, Government Leader, and seconded by Mr. Cable, Member for Riverside:

"THAT Alan Nordling, Member for Porter Creek South, do take the Chair of this Assembly as Speaker."

(Motion #1)

The Clerk, having scanned the House for further nominations, repeated the motion and called for a vote. He then stated:

"I think the 'ayes' have it, and by direction of this Assembly, declare that Alan Nordling is duly elected as Speaker of this Assembly."

SPEAKER'S ADDRESS TO THE ASSEMBLY

The Speaker retired, donned his robe and re-entered the Chamber.

The Government Leader and the Member for Riverside shook hands with the newly-elected Speaker and offered their congratulations.

Standing on the Dais, the Speaker thanked the Assembly as follows:

"I beg to express my grateful thanks and humble acknowledgement of the high honour the Assembly has been pleased to confer upon me."

The Speaker then took his seat and addressed the Clerk as follows:

"Mr. Clerk, will you please advise the Commissioner, in his capacity as Lieutenant-Governor, that the Assembly is now prepared to hear the Speech from the Throne."

The Commissioner returned to the Chamber and took the Chair.

SPEAKER'S ADDRESS TO THE COMMISSIONER

The Speaker then said:

"Sir:

The Legislative Assembly have elected me their Speaker, although I am but little able to fulfil the important duties thus assigned me. If, in the performance of these duties, I should at any time fall into error, I pray the fault may be imputed to me and not to the Assembly, whose servant I am and who, through me, the better to enable them to discharge their duty to their Queen and country, humbly claim all their undoubted rights and privileges, especially that they may have freedom of speech in their debates, access to your person at all seasonable times and that their proceedings may receive from you the most favourable construction."

RESPONSE BY THE COMMISSIONER

The Commissioner then said:

"Mr. Speaker:

I am pleased to declare to you that I freely confide in the duty and attachment of the Assembly and not doubting that the Assembly's proceedings will be conducted with wisdom, temper and prudence, I grant, and upon all occasions will recognize and allow, the Assembly's constitutional privileges. I assure you that the Assembly shall have ready access to me upon all seasonable occasions, and that the Assembly's proceedings, words and actions will constantly receive from me the most favourable construction."

SPEECH FROM THE THRONE

The Commissioner then read the following Speech from the Throne:

Honourable members, it is my pleasure to welcome you to a new legislature and a new session.

We come together at a time of the year when as Yukoners we recall the many gifts we enjoy. We live in land blessed by natural beauty, beauty we have a responsibility to protect. In contrast to many areas of the world, we enjoy a high standard of living and a quality of life few share. Yukoners are a strong, self-reliant people, who possess the ability and talents to build a self-sufficient future for this territory.

With these gifts, we can meet the challenges we face here in the Yukon. In the coming months and years, my government is committed to working with Yukoners to realize our tremendous potential and to enhance the lives of residents of this territory.

It is committed to working towards positive social change that contributes to the well-being of Yukon families and Yukon communities and to the well-being of both our aboriginal and non-aboriginal residents.

It is committed to working towards economic self-sufficiency. It will take steps to strengthen industries, such as mining and tourism, which must form the mainstay of our economy, as well as promote new opportunities to diversify the Yukon's economic base.

It is committed to protecting our northern environment and conserving its abundant resources, which are key to our continued economic, cultural, and social health.

In meeting these challenges, my government will work, with diligence, to provide good government to Yukon residents.

Good Government

My government's duty is to serve Yukoners responsibly. It must be accountable for its decisions, particularly its spending, while it is responsive to the needs of people. The recent review of the territory's finances confirms the need to spend carefully and wisely. My government is responding to this challenge and placing tighter fiscal controls on government expenditures. During this session, it will be issuing a statement on the financial health of the government and interim measures to improve it.

My government recognizes that in these tight financial times government programs must operate more efficiently and economically. It will welcome input from both within and outside government to achieve this goal.

My government will, as well, enhance accountability for its spending by making greater use of this Assembly's Public Accounts Committee. As this committee has recommended in the past, my government will implement measures to ensure that any new facilities are properly planned and built under strict financial controls. My government will also review programs it now delivers to ensure they properly reflect the needs and priorities of Yukon residents.

Advisory committees are an important means of giving Yukoners a direct voice in government decision making. It is also important that the membership of these committees is representative of Yukon society. To this end, my government will be bringing forward a motion during this session to create an all-party legislative committee to review appointments to major government boards and

committees. It is equally committed to listening to and acting on the advice of these boards.

Effective Social Programs

My government is also committed to listening to Yukoners when designing or reforming social programs. It will work with parents and teachers to ensure our school system is preparing our children for the challenges of the 21st century. Our college campuses must also address the needs of the Yukon by offering programs of relevance to the territory and its people.

My government recognizes the importance of social programs to assist people in need and will work to ensure our health care system is meeting the needs of Yukoners. It will make every effort to enhance these services for our seniors and elders and enable them to remain in their own homes as long as they are able. In conjunction with municipal governments and the private sector, it will take steps to meet community needs for adequate housing.

My government will work with First Nations and community groups on educational programs aimed at eliminating violence against women and children. It wants to ensure there is an effective justice system in the territory. This system must be responsive to the needs of all residents. It must offer rehabilitative programs that address the root causes of crimes such as vandalism, while instilling a respect for the law.

My government will also raise with the federal government concerns it has with Canada's Young Offenders Act. It believes more meaningful deterrents are needed to help reduce crime.

A Yukon Land Claims Settlement

Next year will mark twenty years since Yukon Indians tabled their land claim with the federal government. Yukoners believe the time has come to complete the work started with the claim of Yukon First Nations as outlined in Together Today For Our Children Tomorrow, presented to the federal government by the respected Indian elder Elijah Smith.

During this sitting, my government will introduce legislation to ratify the Champagne and Aishihik First Nations land claim and self-government agreements. A Select Committee of this House will be established to review this legislation and ensure the opportunity for Yukoners to comment on and understand these historic agreements, before legislation is approved by this Assembly.

With the passage of this legislation, we will achieve a critical step towards settling the claims of Yukon Indian people, which have been outstanding for too long.

Through land claim and self-government agreements, the Yukon's aboriginal peoples will gain control of their lands and their lives. They will be able to manage their own affairs, rather than have those decisions made for them by federal officials.

Through these agreements, Yukon Indian people will play a key role in working towards the goal of economic self-sufficiency for all Yukoners. My government is committed to working in partnership with Yukon First Nations to fully implement their agreements.

Greater Control Over Yukon Affairs

Just as Yukon First Nations want the ability to manage their lives, all Yukoners want more control over the affairs of this territory. My government will pursue this goal, as integral to its efforts to build a self-sufficient future for Yukon residents.

As part of this effort, we are now negotiating transfers that would see the responsibility for forests and oil and gas rest in Yukon hands. This will enable Yukoners to develop environmentally sound industries based on these natural resources. My government will also be pursuing discussions with the federal government on gaining control over Yukon lands and resources as First Nation settlements are reached.

Investments In Infrastructure

The Yukon cannot expect to continue to rely indefinitely on the federal government to fuel our economy. My government will intensify efforts to use money now received through the federal operating grant to invest in projects that will increasingly enable us to generate our own revenues.

Development projects are often hampered by a lack of adequate infrastructure and the high costs that result from this barrier. Improving our transportation and communication systems and enhancing job training will increase the viability of projects and generate wealth.

My government will also develop the Yukon's energy potential. The mandates of the Yukon Energy Corporation and the Yukon Development Corporation will be changed, so that profits go towards reducing energy costs and developing energy infrastructure. My government will also work with First Nations and other Yukoners to identify small and medium hydroelectric sites that are economically feasible and environmentally responsible. It will explore alternatives to the use of diesel, as well as promote energy conservation.

Economic Diversification

Investments in our transportation system and increasing our

energy infrastructure will help support our major industries, mining and tourism. At the same time, they will help build a positive climate for investing in the development of new economic opportunities here in the Yukon.

To encourage mining further, my government will promote the re-establishment of the flow-through share program and other tax benefits for northern Canada. It will review programs it offers to make them responsive to the industry's needs. It will work to ensure that regulatory processes fairly balance our economic and environmental needs. A climate of certainty for investment and a predictable, efficient regulatory process are essential to a strong industry.

Our mountains, rivers, lakes, and wildlife attract tourists from around the world. My government will work with industry to enhance opportunities to enjoy the natural gifts of our territory. It will also seek to identify and promote new attractions that will give visitors a chance to experience more fully our rich history and culture.

Small business is an integral component of the Yukon's economy. My government will be reviewing its business development programs to ensure they are a help, not a hindrance, to businesspeople throughout the territory. It will be exploring new opportunities to support existing businesses and to promote new ventures in the Yukon.

Environmental Stewardship

In diversifying the Yukon economy, my government is mindful of the obligation it shares with the territory's residents to protect the Yukon's environment and its resources. To act on this responsibility, it will undertake management plans to conserve our wildlife and protect their habitat. Areas of critical habitat and those that are environmentally sensitive will be examined for their suitability as parklands.

Proper sewage facilities for communities are a priority, and my government will work with the federal government, municipalities and First Nations to correct problems with sewage treatment. It will also institute a year-round anti-litter program, called "Yukon Pride". By taking responsibility for our environment, we can protect it for the use and enjoyment by our children and their children.

Honourable Members, the Yukon is a special place. We are blessed with many gifts. We can strengthen our economy and support new and existing businesses, while conserving and protecting the resources that allow us to develop a stronger economic future. We can ensure that our schools, our health care facilities, and our social programs meet the needs of residents here, while recognizing the need to spend within our means. We can rely on the strong,

independent spirit of Yukoners to build together a community that offers much to its individual members, to its families, and to aboriginal and non-aboriginal citizens alike.

My government stands ready to work with Yukoners to build a self-sufficient future for our territory.

The Commissioner then retired from the Chamber.

THAT individual Yukon Land Claim Final Agreements and Yukon First Nation Self-Government Agreements be transmitted to the Committee, subsequent to First Nations ratification, by the Government Leader tabling such agreements in the Legislative Assembly or, if the Legislative Assembly is not then sitting, by the Government Leader delivering such agreements to the Speaker who shall forward copies to all Members of the Legislative Assembly;

THAT the Committee report to the Legislative Assembly no later than the fifth day of the next regular sitting of the Legislative Assembly:

- (a) its recommendation as to whether the Agreement referenced in Bill #2 and considered by the Committee should be accepted or rejected,

The announcement, on Friday, of a two-month shut-down at Faro and a three-month shut-down at Sa Dena Hes, followed by the announcement this morning that Curragh would be seeking protection from its creditors, is new to us and has not been debated by this House.

The other issue of ongoing negotiation has already been the subject of debate in this House and, if it was only a discussion of the negotiations that are going on, I would not have found that it complied with Standing Order 16. However, I do find the two new issues - the shut-downs of the mines for several months and the protection from creditors - is sufficiently urgent that it can be debated under Standing Order 16.

Under that Standing Order, each Member who wishes to speak has up to fifteen minutes. After that, there will not be a vote, but we will simply return to the ordinary business of the day."

A review of the Leader of the Official Opposition's concern indicates that it is not "privilege", in that the essential element of privilege is the right of free speech in this House. More accurately, I would think that the Leader of the Official Opposition would have brought this under a point of order. As I was given notice of this potential point of order, parliamentary authorities were reviewed and the Table Research Branch of the House of Commons was consulted. There are no rules or precedents that we were able to find that would stop the Government from introducing amendments to reduce a number of line items in the Main Estimates it presented to the House in March of this year.

Clearly, this is an unusual approach. The lack of precedent cannot be taken to imply that the Government cannot introduce these amendments. In a minority situation, as the Leader of the Official Opposition has said, it should be expected that some unique procedures may be utilized as the Government seeks to obtain the support of a majority of the Members in the House.

Therefore, I find that it is not a question of privilege nor a point of order. I cannot provide the Leader of the Official Opposition with the remedy he seeks; however, I should say that I have great sympathy for the Leader of the Official Opposition's point of concern. I hope that it has been satisfied by the Government Leader offering to provide a list immediately of those items that are anticipated to

be changed in the Main Estimates so that the Opposition has them before we begin debate on the budget and there can be full and informed debate on those items."

CASTING VOTE

There being equal number of votes, the Speaker stated:

"Our Standing Orders require that in the event of a tie vote the Speaker shall cast the deciding vote.

It has been generally accepted, and is set out in Beauchesne, that when a tie-breaking or casting vote is necessary, the Speaker is entitled to vote, like any other Member, according to conscience. Beauchesne goes on to say that the Speaker votes in such a manner as to leave the House another opportunity to decide the question.

Normally, a vote at Third Reading is a final decision and leaves the House no opportunity for further debate; however, the situation with Bill #20 is rather unique in that it is not, in a sense, a stand-alone Bill; it is part of the Government's

budget package, which also includes Bill #6, the Main Estimates.

The Main Estimates are presently in Committee of the Whole and the House has just begun to debate the Capital and the Operation and Maintenance Estimates for 1993-94. Bill #20 is simply part of the revenue side of that total budget package.

However Bill #20 is also critical because it is a tax Bill. As such, it is a question of confidence. As a question of confidence, the Government will stand or fall based on the passage or defeat of the Bill.

This, then puts the Speaker in somewhat of a dilemma. If I support this Bill, I am offending the principle that significant decisions should not be taken except by a clear majority of the House. However, if I vote against the Bill, the Government will fall and the House will not have the opportunity to further debate the more significant and more complete decision, which is the main budget itself.

My conscience tells me that the House should have the opportunity to fully debate and vote on the complete budget. On that basis, I will vote for the motion and declare the motion for Third Reading carried and that Bill #20 has passed this House."

SPEAKER'S RULING ON QUESTION OF PRIVILEGE

"I will now rule on the question of privilege raised by the Member for Riverdale South yesterday.

When a question of privilege is raised by a Member, the responsibility of the Speaker is set out in Standing Order 7(3) which states, 'The Speaker may allow such debate as is necessary to assist in the determination of whether there appears to be a prima facie case of breach of privilege and whether the matter is being raised at the earliest opportunity.'

The Member for Riverdale South, pursuant to the requirements of Standing Order 7(1), provided written notice of the question of privilege which she has raised.

Her oral remarks did not cover all the points identified in the written notice so I will now table a copy of that notice.

The written notice provides the reasoning behind the Member for Riverdale South's submission that there was a breach of privilege.

To determine whether there is a prima facie breach of privilege, I have considered the written notice, the oral remarks of the Members when the question of privilege was raised, and I have reviewed the comments made by the Leader of the Official Opposition, at page 1077 of Hansard, and also remarks by other Members who spoke immediately after the Leader of the Official Opposition.

The Member for Riverdale South, in a portion of her written notice, said the following and I quote, 'On Wednesday, May 26, the Leader of the Official Opposition, in his speech on Second Reading of Bill #89, made some very serious allegations concerning the Speaker.' Later on she concludes, 'It is my feeling that the statements of the Official Opposition on May 26 were in the nature of a breach of privilege, because they contained reflections upon the character and actions of the Speaker. According to parliamentary practice, the Leader of the Official Opposition should have brought forward a substantive motion if he has a specific charge to level.'

In support of her position, the Member for Riverdale South cites a portion of annotation 168 in Beauchesne's Sixth Edition which states: 'Reflections upon the character or actions of the Speaker may be punished as breaches of privilege. The actions of the Speaker cannot be criticized incidentally in debate or upon any form of proceeding except by way of a substantive motion.'

During the Second Reading debate on the Bill, entitled An Act to Amend the Fuel Oil Tax Act, the Leader of the Official Opposition at one point stated, 'We have learned today one dimension of an understanding that obviously exists to secure passage of this legislation. Members in this party, the Official Opposition, are quite appalled and scandalized by those arrangements.'

He then went on to discuss the selection of the Speaker as the Yukon Branch delegate to the annual conference of the Commonwealth Parliamentary Association. He then concluded that portion of his speech with the following remarks: 'The Government Leader told us today that there were no deals to guarantee the passage of his

budget and I am going to stand here on my feet in this House and say that I find that statement incredible. What has transpired, Mr. Speaker, I want to say frankly, dishonours this House, dishonours all Members of this House and demeans the budget debate.'

It is apparent, upon reflection, that not only was the Leader of the Official Opposition in breach of our Standing Order 57(2), which requires that the debate on a motion for Second Reading must be limited to the object, expediency, principles and merits of the Bill or to alternative methods of obtaining its purpose but the remarks were, in my determination, clearly reflections upon the character and actions of the Speaker.

From the speeches on the tax Bill that followed the Leader of the Official Opposition's remarks, it is apparent that other Members also interpreted the remarks made by the Leader of the Official Opposition as an attack on the Speaker.

The Member for Riverside spoke immediately after the Leader of the Official Opposition. He said, 'I had not intended to speak but I cannot believe my ears. The word 'scandalous' was used. The suggestion that a Member of this House would trade off some travel budget for support of a Bill, I think is, in fact, scandalous. If in fact I have appreciated those allegations correctly, they should either be proven or withdrawn in order that the Speaker's position can be protected.'

The Minister of Justice, in his remarks said, 'Let us look at the attack on the Speaker by the Leader of the Official Opposition. In my view, that was unparliamentary. Attacking the Chair, as he has during this Session, is unparliamentary. Attacking the officials of this Legislature is unparliamentary. There are other forums in which to discuss these things. They should not be brought out here in the first instance. That is, simply, my position.'

The Government House Leader in his speech stated 'The issue has also come up where one Member attacked the Speaker today in the House. I am disappointed about that. I am not going to say much more than that. That particular Member has taken leave of the standard rules of this House and consistently attacked the Speaker, Table Officers, Government officials and others in here. That is sad for our House, and it really lowers the level of debate in our Legislature.'

The Government House Leader went on to say, 'I know that, if I were taking that approach, that particular Member would be the first Member to stand in his place and chastise me for attacking people who cannot defend themselves.'

I, therefore, find that the remarks made by the Leader of the Official Opposition constitute a prima facie breach of privilege; however, the Member, in bringing a question of privilege, must also clear two further hurdles. The matter must be raised at the earliest opportunity and quoting from annotation 118 in Beauchesne's Sixth Edition, 'A complaint of a breach of privilege must conclude with a motion providing the House an opportunity to take some action. That action is normally the reference of the matter to the Standing Committee on Elections, Privileges, and Procedure for examination. It may, however, be a statement of condemnation for a breach of privilege or an order for an individual to appear at the Bar.'

Maingot, in "Parliamentary Privilege in Canada", states that one of the facets of an acceptable motion on a question of privilege is that the motion should refer to the complaint raised by the Member.

The motion proposed in the written notice reads as follows: 'THAT this House finds that the Leader of the Official Opposition, in his remarks about the Speaker on May 26, 1993, as found on page 1077 of Hansard, has committed a breach of privilege; and

'THAT this House continues to support the long-standing parliamentary principle that the actions of the Speaker cannot be criticized incidentally in debate or upon any form of proceeding except by way of a substantive motion.'

The motion that the Member for Riverdale South informed the House that she wished to debate included only the second paragraph of the motion found in her written notice. Obviously, the motion intended by the Member must be taken to be the one she provided to the House in her oral presentation. By dropping the first paragraph of the motion, the Member for Riverdale South has eliminated any reference to her specific complaint. She therefore, has not brought forward a motion that could be considered to be in order.

On that point, though, issues as important as questions of privilege ought not to fail based on form

alone. I have therefore, considered whether the matter is being raised at the earliest opportunity. In the absence of extenuating circumstances, the matter should be raised either at the time of the alleged breach or on the next sitting day.

Extenuating circumstances were not argued by the Member and are not obvious to me.

Based on the fact that the Member is asking the House to debate a very general motion, which does not refer to a specific complaint, or give specific direction for action to be taken, and also the fact that no argument was made with respect to the delay in bringing the question, I cannot justify setting aside all other business of the House to debate this motion. I would suggest that if Members wish to proceed with the motion, that it be brought forward again in the normal course of business. We will now proceed to Orders of the Day."

CASTING VOTE

There being an equal number of votes, the Speaker made the following statement before giving the casting vote:

"There is a tie vote on the motion for Third Reading of this bill.

The Standing Orders of the Yukon Legislative Assembly state at 4(2): 'In the event of a tie vote, the Speaker shall cast the deciding vote and any reasons stated shall be entered in the Votes and Proceedings.'

Further, the Legislative Assembly Act states at section 29: 'When the number of votes cast for and against a motion are equal, the Speaker shall give the casting vote.'

Neither our Standing Orders nor the Legislative Assembly Act provide direction to the Speaker on the use of the casting vote. Rather, they specify only that the Speaker must vote in the event of a tie.

Parliamentary authorities and the precedents of this Assembly provide some assistance as to how the Speaker should exercise this responsibility.

Annotation 310(1) of Beauchesne's Sixth Edition states: 'When a tie-breaking or casting vote is necessary, the Speaker is entitled to vote like any other Member, according to conscience, without assigning a reason; but in order to avoid the least suggestion of partiality, it is usual when practicable, to vote in such a manner as not to make the decision of the House final, and to give reasons which are entered in the Journals. The Speaker votes in such a manner as to leave the House another opportunity of deciding the question.'

A useful document in this respect is a procedural paper entitled "The Casting Vote of the Chair" prepared by the Table Research Branch of the House of Commons.

In the introduction of this procedural paper the following general statement is made: 'Since the exercise of this responsibility (i.e., the use of the casting vote) could involve the Chair implicitly in partisan debate and thus weaken confidence in the Chair's impartiality, certain conventions have developed to guide Speakers and Chairmen in the exercise of the casting vote.'

The paper quotes John George Bourinot, a former Clerk of the House of Commons of Canada, who wrote, in his book

"Parliamentary Procedure and Practice in the Dominion of Canada", that 'it will be found that the general principle which guides a speaker or chairman of committee of the whole on such occasions is to vote, when practicable, in such a manner as not to make the decision of the house final.'

The procedural paper also reviews the experience of the Speakers of the British House of Commons in the use of the casting vote. The paper states: 'From an analysis of the instances in which the casting vote of the Chair has been exercised at Westminster, the following principles emerge:

- (1) The Chair should always vote for further discussion.
- (2) Where no further discussion is possible, important decisions should not be taken except by a majority.
- (3) Cognate to (2) above, where legislation is concerned, the bill should be left in its existing form.

Simply put, the Chair should always vote for the status quo.'

The principle that the Chair should always vote for further discussion and not make the decision of the House final was cited by me during this Session when casting the deciding vote on the motions for Second Reading of Bill #20, An Act to Amend the Income Tax Act, and of Bill #6, First Appropriation Act, 1993-94. It was also cited when I cast the deciding vote for Third Reading and passage of Bill #20, An Act to Amend the Income Tax Act. At that time I made it clear that the vote to pass Bill #20 was cast for the purpose of allowing the House to 'fully debate and vote on the complete budget' which has, as a central component, Bill #6, First Appropriation Act, 1993-94, which we are now dealing with.

In the procedural paper quoted, not a single reference is made to an occasion on which a Speaker has been required to cast the deciding vote in a situation like the one I am faced with today.

The question now before the House is clearly one on which the fate of the Government hinges. It is a matter of confidence and, if the motion does not carry, the Government will fall.

The principle that the Speaker should always vote for further discussion cannot be relied upon as this is the final vote on this budget; it either passes or fails.

The second principle is that, where no further discussion is possible, important decisions should not be

taken except by a majority. The dilemma that I face, if I rely on that principle, is that the deciding vote, by necessity, creates a majority for one side or the other. If I vote in favour of the motion, it passes the budget -- a most important decision. On the other hand, if I vote against the budget, my vote will cause an election -- again, a most important decision.

An argument can be made that it is the responsibility of the House and not the Speaker to support a government. This idea is explained by John Stewart in his book "The Canadian House of Commons". Mr. Stewart states, 'Obviously, when we say that one function of the House is to support a government, we are not saying that the House never should defeat a government. Ordinarily, if the government is in a minority position it will be defeated just as soon as the third party decides that, all things considered, including the public reaction, its own partisan commitments require it to bring the government down, and not before.'

But the members always have an obligation to act primarily as good members of the House, that is, to put the maintenance of the constitutional system ahead of personal and party interests. This obligation is honoured every day in diverse ways --- by consultation over the order of business, by waiving the rules when to do so is desirable, . . ., etc. The obligation becomes most obvious and important when it has been demonstrated - two general elections in close proximity suffice - that no party can obtain a majority. In that situation, I suggest, all members are under an obligation to moderate their party loyalties, whether based on religion, race, region, class, or tradition, or all these mixed, to permit Responsible Government to work. Compromises by both the government and the opposition will be required. The government will have to accept minor defeats in the House without resigning, and without calling an election. The opposition will have to meet the government half way.'

The point which must be made is that the House, including both the Government and the Opposition, should not come to rely on the vote of the Speaker. That would do a disservice to both the House and the Speaker. This House, too, should support the principle of an impartial Speaker. If it insists on making the Speaker part of the decision-making process, it risks doing harm to the position.

In considering how to vote on Bill #6, I have taken careful account of the fact that the House has not been able to achieve a majority either supporting or opposing

the Bill and of the effect that this deciding vote will have upon the position of the Speaker.

I would point out the obvious. Excluding Porter Creek South, representatives of half of the electoral districts of the Yukon support this budget and representatives of the other half do not.

In our system, the Speaker is also a representative of the constituents who elected him or her. My situation as Speaker is somewhat unique in that I was elected in Porter Creek South as an Independent. I say that so it is clear that this decision has not been influenced in any way by loyalty or allegiance to a political party.

I will also say for the record that I have not entered into any prior arrangements or agreements with either the Government side to support this budget or with the Opposition to defeat it.

In the role of a constituency representative, and, as the possibility of a tie vote existed due to the make up of this House, I attempted to contact all my constituents to obtain their opinion. I canvassed the constituents of Porter Creek South to determine their views on the budget, the performance of the Government and the desirability of a general election.

I apologize to those we never got hold of and to those who wanted to speak with me personally that I was unable to call back.

Many of my constituents do not like this budget. They are especially upset about the tax increases which were not only unwelcome but also unexpected.

I do not hesitate to state clearly on the record that I do not like this budget.

The clear majority of my constituents, at the same time, believe that the Government deserves more time to prove whether or not it can provide good government and that the majority of my constituents do not want to see a general election at this time.

That is the larger issue to be considered --- whether or not the Government should be defeated, sending Yukoners back to the polls.

We are presently seven months into the mandate of a new Government which has replaced the seven year reign of the previous Government.

Although I have not conducted a survey of the entire Yukon, I believe that the response received from the constituents of Porter Creek South to be representative of the views of a majority of Yukoners.

In reaching a decision, I felt it necessary to make a general assessment of the "mood" of the elected representatives as well as the electorate. As Speaker, I, first and foremost, must be concerned with the activities which take place within this Chamber. Although debate on some measures has been quite extensive, every Bill introduced by the Government has, at this point, been passed or reached the Third Reading stage. Those debates have not been so obstructionist as to cause the Government to be unable to get its legislative program through the House nor have unceasing demands been made for the Government to go to the people. I must conclude that, by carrying on business, the Members are reflecting the mood expressed by their constituents and that the desire of this House is to allow this Government to remain in office for the time being.

In conclusion, I return to the simple fact that the Speaker is entitled to vote, like any other member, according to conscience.

In reaching a decision on how to cast the deciding vote I have considered my duty to this House as Speaker, my duty to my constituents as their representative and my duty to all Yukoners as an elected Member of this Legislative Assembly.

I do not sense a strong feeling that Yukoners are ready for and want an election.

For that reason and those previously mentioned, I vote for the motion and declare that Bill #6 has passed this House."

1. Motion #1 – December 14, 1992 – Hon. Mr. Ostashek, Government Leader

THAT Alan Nordling, Member for Porter Creek South, do take the Chair of this Assembly as Speaker.

2. Motion #2 – December 14, 1992 – Hon. Mr. Phillips, Government House Leader

THAT Johnny Abel, Member for Vuntut Gwich'in, be appointed Deputy Speaker and Chair of the Committee of the Whole.

3. Motion #3 – December 14, 1992 – Hon. Mr. Phillips, Government House Leader

THAT David Millar, Member for Klondike, be appointed Deputy Chair of the Committee of the Whole.

4. Motion #5 – December 16, 1992 – Hon. Mr. Ostashek, Government Leader

THAT it is the recommendation of this Assembly that the honourable Members John Ostashek, Bill Brewster, and Willard Phelps be appointed to the Advisory Committee on Finance and that the honourable Members Doug Phillips, John Devries and Mickey Fisher be appointed as alternate members of the same committee.

5. Motion #7 – December 16, 1992 – Hon. Mr. Ostashek, Government Leader

THAT a Special Committee on Land Claims and Self-Government be established;
THAT the Committee be comprised of seven members of the Legislative Assembly;
THAT the Honourable John Ostashek be the Chair of the Committee;
THAT the remaining six members of the Committee are as follows: three members appointed by the Government Leader, two members appointed by the Leader of the Official Opposition and the honourable Member for Riverside;
THAT Bill #2, entitled An Act Approving Yukon Land Claim Final Agreements, and Bill #3, entitled First Nations (Yukon) Self-Government Act, be referred to the Committee;
THAT individual Yukon Land Claim Final Agreements and Yukon First Nation Self-Government Agreements be transmitted to the Committee, subsequent to First Nations ratification, by the Government Leader tabling such agreements in the Legislative Assembly or, if the Legislative Assembly is not then sitting, by the Government Leader delivering such agreements to the Speaker who shall forward copies to all Members of the Legislative Assembly;

THAT the Committee report to the Legislative Assembly no later than the fifth day of the next regular sitting of the Legislative Assembly:

- (a) its recommendation as to whether the Agreement referenced in Bill #2 and considered by the Committee should be accepted or rejected,
- (b) its recommendation as to whether the Self-Government Agreement referenced in Bill #3, and considered by the Committee should be accepted or rejected,
- (c) its findings, if any, relating to the subject matter of Bill #2 and Bill #3, and
- (d) its recommendations, if any, for amendments to the clauses of Bill #2 and Bill #3;

THAT, in the event the Legislative Assembly is not sitting at the time that the Committee is prepared to report, the Chair of the Committee forward copies of the report to all Members of the Legislative Assembly, thereafter make the report public, and subsequently present the report to the Legislative Assembly at the next sitting of the Legislative Assembly;

THAT, at such time as the Committee has reported to the Legislative Assembly, Bill #2, Bill #3, any agreements considered by the Committee and the report of the Committee stand automatically referred to the Committee of the Whole;

THAT, during its review of Bill #2 and Bill #3, the Committee be empowered:

- (a) to send for officials from the Land Claims Secretariat of the Government of the Yukon to appear as witnesses on technical matters,
- (b) to invite such other persons as it deems necessary to appear as witnesses on technical matters,
- (c) to hold public hearings,
- (d) to create a sub-committee or sub-committees which can question witnesses, receive oral submission and conduct public hearings but which cannot make decisions on behalf of the Committee, and
- (e) to print such papers and evidence as may be ordered by it; and

THAT the Clerk of the Legislative Assembly be responsible for providing the necessary support services to the Committee.

6. Motion #8 – December 16, 1992 – Hon. Mr. Phillips, Government House Leader

THAT this House does not recognize the Independent Alliance as a third party in this House; and

THAT this House orders that the Independent Alliance should not be accorded privileges as if it were a party in opposition to the government.

THAT this House urges the Implementation Review Committee to recommend realistic placer mining regulations that will promote the development and growth of the placer mining industry while protecting the Yukon's fishery resource.
