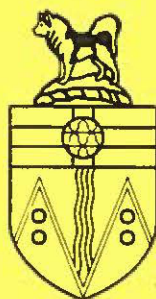

**ELECTION OF SPEAKER**

At 1:30 p.m. the Clerk addressed the House:

"Honourable Members of the Assembly, on February 23, 1994, I received, from the Hon. Alan Nordling, the following communication addressed to me as Clerk of the Assembly:

The Speaker-nominee left the Chamber upon his nomination having been made.

The Clerk, having scanned the House for further nominations, repeated the motion, asked if the motion nominating Mr. Devries should carry and then said:

"I think the 'ayes' have it, and by direction of the Assembly, declare that Mr. John Devries is duly elected as Speaker of this Assembly."

The Deputy Clerk left the Chamber to advise Mr. Devries that he had been duly elected as Speaker.

The Speaker donned his robe and entered the Chamber.

The Government Leader shook hands with the newly-elected Speaker and offered his congratulations.

#### SPEAKER'S ADDRESS TO THE ASSEMBLY

Standing at his Chair, the Speaker thanked the Assembly as follows:

"I will repeat the first words traditionally spoken by a newly-elected Speaker: 'I would like to express my humble thanks and grateful acknowledgement to the House for the honour which it has bestowed upon me by choosing me to be its Speaker.'"

  5. Ecological Sustainability: The obligation of the community to practice responsible stewardship of the earth and its environment, so that creation might be preserved for generations to come; and
  6. Fiscal Fairness: The responsibility of all to contribute fairly for the well being of all."

Further to the authorities cited by Speaker Johnston earlier in 1992, I would also refer the House to Standing Order 19, which states, 'A Member will be called to order by the Speaker if that Member:

- (h) imputes false or unavowed motives to another Member;
- (j) uses abusive or insulting language or a nature likely to create disorder.'

Additionally, guideline 8 of the Guidelines for Oral Question Period states, 'A question must adhere to the properties of the House in that it must not contain inferences, impute motives of cast aspersions upon persons within the House or out of it.'

It is clear that allegations such as those that were made concerning the Government Leader constitute unparliamentary language and, if they are to be made, must be placed before the House in the form of a motion."
