The Clerk of the Legislative Assembly reported on the Members elected to the Yukon Legislative Assembly as follows:

<u>Clerk advises House that Commissioner will not deliver Speech from the Throne until Speaker is elected</u>

The Commissioner, the Hon. Geraldine Van Bibber, entered the Chamber and took the Chair.

The Clerk of the Legislative Assembly then stated:

"I am commanded by the Commissioner, in her capacity as Lieutenant-Governor, to state that she does not see fit to declare the causes of the summoning of the present Assembly until a Speaker of this Assembly shall have been chosen according to law, but today at a subsequent hour she will declare the causes of the calling of this Assembly."

The Commissioner then retired from the Chamber.

ELECTION OF SPEAKER

The Clerk addressed the House:

"Honourable Members, nominations are invited for the office of Speaker of this Assembly."

It was moved by the Hon. Mr. Fentie, Premier, and seconded by Mr. Mitchell, Leader of the Official Opposition, and Mr. Cardiff, Acting Leader of the Third Party:

"THAT Ted Staffen, Member for Riverdale North, do take the Chair of this Assembly as Speaker." (Motion #1)

The Clerk, having scanned the House for further nominations, repeated the motion and called for a vote. He then stated:

"The ayes have it, and Ted Staffen, Member for Riverdale North, is, by direction of this Assembly, duly elected as Speaker of the Yukon Legislative Assembly."

SPEAKER'S ADDRESS TO THE ASSEMBLY

The Speaker retired, donned his robe and re-entered the Chamber.

The Premier, the Official Opposition House Leader, and the Acting Leader of the Third Party shook hands with the newly-elected Speaker and offered their congratulations.

Standing on the Dais, the Speaker thanked the Assembly as follows:

"I would like to express my thanks to the Assembly for the great honour it has given me by electing me to be its Speaker.

I would also like to take this opportunity to thank my wife, Susan, our son, Jess, and our daughter, Bailey, for their unqualified support. I'd also like to express my gratitude to the constituents of Riverdale North for reelecting me. I look forward to representing and serving you in the future. Thank you."

The Speaker then took his seat and addressed the Clerk as follows:

"Mr. Clerk, will you please advise the Commissioner, in her capacity as Lieutenant-Governor, that the Assembly is now prepared to hear the Speech from the Throne."

The Commissioner returned to the Chamber and took the Chair.

SPEAKER'S ADDRESS TO THE COMMISSIONER

The Speaker then said:

"Madame Commissioner:

The Members of the Legislative Assembly have elected me to be their Speaker and I recognize the important duties now given to me. If, in the performance of those duties, I should at any time make a mistake, the fault is mine and not that of the Assembly, whose servant I am. At this time, so that all Members of the Assembly can best carry out their duty to Yukon, to their country and to the Queen, I would claim for them their undoubted rights and privileges, especially freedom of speech in their debates, access to your

person when necessary, and your favourable consideration of their proceedings."

RESPONSE BY THE COMMISSIONER

The Commissioner then said:

"Mr. Speaker:

I am pleased to declare to you that I believe in the duty of the Assembly and, not doubting that the Assembly's proceedings will be conducted with wisdom, temper and care, I grant and allow the Assembly's constitutional privileges. I assure you that the Assembly shall have ready access to me and that the Assembly's proceedings, words and actions will receive from me favourable consideration."

SPEECH FROM THE THRONE

The Commissioner then delivered the Speech from the Throne as follows:

"Mr. Speaker, Members of the Yukon Legislative Assembly, Yukoners, visitors and honoured guests, I welcome you in our Sovereign's name to the First Session of the Thirty-Second Legislative Assembly.

In today's Yukon, there is a rekindled economy, unemployment is at historic lows, our population is increasing, property values are on the rise and my government's financial health is among the best of all jurisdictions in Canada.

The Yukon is poised to continue its advance on the pathway to growth and prosperity by continuing the vision and the direction that was established by my government in the election of 2002.

It was through dedication and hard work that my government built a strong foundation for Yukon's future over the past four years. On October 10, 2006, my government received a second mandate from the people of Yukon to continue to advance and to keep the territory on its current pathway of growth and prosperity.

It is worthy to note that my government is the only government since 1989 to achieve a second mandate. This is indeed historic and clearly demonstrates that the people of Yukon wanted political stability and continuity.

Building Yukon's Future Together

My government's vision, "Building Yukon's Future Together – A Clear Vision for a Bright Future," has four major pillars:

- achieving a better quality of life by building healthy, safe communities with skilled and adaptable people;
- protecting Yukon's pristine environment, preserving our wildlife; and studying and mitigating the impacts of climate change;
- promoting a strong, diversified private sector economy by developing Yukon's vast natural resources, wilderness tourism potential, agriculture, arts and culture, information technology, and film and sound, as well as the traditional industries of outfitting and trapping; and
- practising good governance with strong fiscal management and a climate of cooperation, collaboration and partnership with our First Nation governments, our two sister territories, our provincial counterparts and the federal government.

These are the pillars upon which my government will build Yukon's future.

In the recent 2006 election, my government asked Yukoners to imagine a better and brighter tomorrow.

It asked Yukoners to imagine a tomorrow where our children are not faced with crack houses and drug dealers in their neighbourhoods.

In order to achieve this objective, my government is committed to implementing its Substance Abuse Action Plan based on four strategic directions: harm reduction, prevention and education, treatment and enforcement.

My government has stated that there will be zero-tolerance for drug dealers and that the enforcement provisions of the Substance Abuse Action Plan will be utilized to ensure drug houses are shut down in Yukon and drug dealers leave the territory.

One of the enforcement tools is the *Safer Communities and Neighbourhoods Act* that allows enforcement officers to shut down drug houses and other illegal activities in our communities.

Investigators have now been hired and the office should be in operation in the very near future.

My government is also focusing on new treatment options and facilities for those who have become addicted to drugs in accordance with the initiatives outlined in its Corrections Action Plan.

To this end, my government will be introducing a therapeutic problem-solving court to the Yukon justice system where those offenders with challenges, such as addictions, FASD, or mental health problems are able to work with the court in a 'holistic' manner to address the treatment needs of the offender.

During the election, Yukoners were asked to imagine a tomorrow where our elders and seniors are able to stay in their homes and within their communities as their needs increase.

To achieve this end, my government is committed to delivering expanded homecare services, re-opening the Thomson Centre, establishing a palliative care unit, and consulting with Yukoners on new elders and seniors facilities in Teslin and other communities in addition to those being planned or under construction in Watson Lake, Dawson City and Haines Junction.

Yukoners were also asked to imagine a tomorrow where affordable, accessible, high-quality childcare and early learning services are available for children and parents in all Yukon communities.

My government is committed to delivering a territorywide childcare and early learning strategy for children and parents based on the priorities that parents themselves have established.

Yukoners were asked to imagine a tomorrow where children with disabilities receive therapies and support services they need to achieve their full potential and live happy productive lives.

My government is committed to expanding support services currently provided to children with autism to include children with other severe disabilities such as cerebral palsy, muscular dystrophy and Down syndrome.

Yukoners were asked to imagine a tomorrow with more doctors and other health care professionals because more of our children have been given access to higher education and have returned home to practice here.

My government is committed to ensuring that Yukon families have improved access to the doctors and other medical professionals they need through measures designed to increase accessible health care for Yukon families.

Yukoners were asked to imagine a tomorrow where all the skills and trades training that Yukoners and their children need is available in Yukon schools and more and more Yukon children are able to graduate from high school and pursue post-secondary education.

My government is committed to introducing a comprehensive skills and trades training strategy to meet the needs of our growing and prosperous economy and to implement the findings of its major Education Reform initiative.

Yukoners were asked to imagine a tomorrow where help is available for seniors, stay-at-home parents, those on social assistance and students to participate in the job market.

My government is committed to assisting potential employees to enter the labour market and help employees fill existing vacancies in the entry-level work force.

Yukoners were asked to imagine a tomorrow where Yukoners have ready access to land to meet their needs.

My government is committed to making land available to Yukoners for community, residential, recreational, agricultural, commercial and industrial purposes while respecting the interests of existing land holders.

This will be accomplished by streamlining the land application process and ensuring that appropriate policies and administrative structures are put in place to manage Crown land in the territory.

Yukoners were asked to imagine a tomorrow where the Yukon is renowned for taking innovative steps to address climate change with its own Climate Change Research Centre of Excellence for the North.

As part of its Climate Change Strategy, my government is committed to:

- establishing Yukon College as a Climate Change Research Centre of Excellence for the North;
- building a Cold Climate Innovation Cluster situated at Ayamdigut Campus at Yukon College to specialize in three general areas of cold climate technology including building construction and maintenance, municipal infrastructure and geotechnical works;
- increasing inventory monitoring, data collection and research on the impacts of climate change on the Porcupine Caribou Herd and other wildlife species such as moose, caribou, bears and Yukon wood bison;
- promoting the Old Crow Campus of Yukon College as an integral part of research on the Porcupine Caribou Herd to ensure local and traditional knowledge is utilized in strategies to lessen the impacts of climate change; and
- including the Yukon Wildlife Preserve as an affiliate of the Yukon College Climate Change Research Centre of Excellence in order to study the impacts of climate change on Yukon wildlife.

Yukoners were asked to imagine a tomorrow where the Yukon is renowned for protecting, preserving and celebrating its pristine environment, sensitive ecosystems and wilderness landscapes for the benefit of future generations and the global community.

My government is committed to meeting its obligations to establish Special Management Areas and Habitat Protection Areas under the land claims settlements as well as to plan and manage a system of wilderness preserves, natural environment parks and ecological reserves throughout the territory.

As part of this initiative, my government is committed to showcasing Yukon parks and urging the Government of Canada to increase its investment in its three national parks in Yukon, including Parks Canada's presence in Dawson City.

Yukon's breathtaking wilderness has been identified as one of the major drivers in promoting the future economic growth of the territory.

Yukoners were asked to imagine a prosperous tomorrow whereby economic activity will be robust from now into the foreseeable future fueled by the demand for the territory's abundance of mineral, oil and gas and other resources as well as a dramatic expansion in the tourism sector due to an increasing demand by international travelers seeking to experience Yukon's breathtaking wilderness and northern cultures.

My government is committed to providing access to land, regulatory certainty, business incentive and marketing programs, and the provision of necessary transportation and energy infrastructure to support the development and growth of a prosperous and diversified private sector economy.

Yukoners were asked to imagine a tomorrow with the Yukon coming of age through effective leadership, political stability, cooperative governance and strong fiscal management.

My government is committed to continuing its cooperative approach to governance whether it be with municipal governments, First Nation governments, our two sister territories, neighbouring jurisdictions such as Alaska, British Columbia and Alberta, the provincial governments, through the Council of the Federation and the Government of Canada.

My government is committed to working with the Northwest Territories, Nunavut and Canada to create a new Northern Vision demonstrating that Canada north of 60 is coming of age, that Canada's northern frontier will become Canada's future and that the territories will play an increasingly important role in Canadian confederation. The fact that Yukon, in collaboration with its two sister territories, is hosting the 2007 Canada Winter Games is an acknowledgement of this new reality and gives the North an opportunity to showcase itself to southern Canadians.

My government remains committed to completing and implementing land claims as well as making First Nations full partners in the economic development of the territory.

To accomplish this end, my government will work with First Nations, Yukon College and the private sector to provide training for Yukon First Nations for land claims implementation, especially in relation to capacity development for First Nation governance.

My government looks forward to continuing our constructive and cooperative relationship with the dynamic Yukon francophone community.

It also remains committed to practising open, accountable, fiscally responsible government through legislative renewal and the provision of balanced budgets as the way of the future.

My government is committed to working constructively with all members of the House to improve the operation of its committees and the proceedings of the legislature itself.

Most importantly, my government will work closely with all Yukoners, whether it be in the private or public sector to ensure a future filled with promise for every one of our citizens.

During this sitting Honourable Members will be asked to consider Bill No. 2 the *Fourth Appropriation Act* 2005-06, Bill No. 3 Second Appropriation Act 2006-07 and Bill No. 31 - Act to Amend the Income Tax Act.

May divine providence attend your deliberations. I thank you in our Sovereign's name. God Bless Yukon and God Bless Canada."

The Commissioner then retired from the Chamber.

The Speaker resumed the Chair and prior to calling the House to order, informed the House that former Speaker Sam Johnston, would be received to give the opening prayer and directed the Sergeant-at-Arms to escort Mr. Johnston to the Table.

At the conclusion of the opening prayer, the Speaker called the House to order.

The Government has introduced the bills that were agreed upon. Also, notice of the motion appointing the Standing Committee on Rules, Elections and Privileges now appears on the Order Paper. That motion clearly reflects the agreement respecting its membership and its Chair.

The matters that the House must indicate its agreement on are the closing day for this Fall Sitting and the manner in which the business of the House will be dealt with on that closing day.

Therefore, on behalf of the House Leaders, I request the unanimous consent of the House that:

- (1) the closing day of the 2006 Fall Sitting be Wednesday, December 13, 2006; and
- (2) the provisions of Standing Order 76 apply on December 13 in the same fashion as if that closing day had been established pursuant to Standing Order 75."

SPEAKER'S STATEMENT (Re: comments made during tabling documents)

Before proceeding with Tabling Returns and Documents the Chair made the following statement on an event that occurred during Tabling Returns and Documents on Thursday, November 30, 2006:

"At that time the Member for McIntyre-Takhini tabled a document. In doing so the member made additional comments about the document's contents. That is not in order. When tabling a document members should restrict themselves to the title of the document or a description of its subject matter. Editorializing about its contents is not in order as Tabling Returns and Documents is not an opportunity for debate and other members are not able to respond to any comments made by the member tabling the document."

QUESTION OF PRIVILEGE

Mr. Cardiff, Third Party House Leader, pursuant to Standing Order 7(1), rose on a Question of Privilege, regarding comments made by the Minister responsible for the Yukon Housing Corporation, during Question Period on Thursday, November 30, 2006.

Speaker's Ruling

"Before discussing the substance of the Question of Privilege the Chair will deal with some procedural matters. The acting Leader of the Third Party met the notice requirement found in Standing Order 7(1)(b) by submitting a written notice to the office of the Speaker by 11:00 a.m. today. Standing Order 7(4) states that the Speaker must rule on (a) whether there appears, on the face of it, to be a case of breach of privilege, and (b) whether the matter has been raised at the earliest opportunity.

The normal practice of this House has been that, to meet the 'earliest opportunity' requirement, a Question of Privilege must be raised at the time the event occurred or on the next sitting day. In this matter, the event in question took place on Thursday, November 30, 2006. Raising the question of privilege on the next sitting day meets the "earliest opportunity" requirement of Standing Order 7(4)(b).

In dealing with Questions of Privilege it is not the Chair's role to rule that a breach of privilege has, or has not, occurred. The question for the Chair to decide is whether there appears, on the face of it, to be a breach of privilege. Should the Chair decide that is the case the acting Leader of the Third Party will be invited to place before the House a motion that would deal with the issue. All other business before the House, with the exception of the Daily Routine, will be set aside until the issue is dealt with.

Should the Chair decide that there does not appear to be a breach of privilege the acting Leader of the Third Party may still bring this issue before the House. This could be done by giving notice of a substantive motion in the usual fashion, which could then be called on a day when Opposition Private Members Business has precedence.

In order to rule on the Question of Privilege we must first consider the nature of parliamentary privilege. According to *House of Commons Procedure and Practice* the term 'Parliamentary Privilege refers...to the rights and immunities that are deemed necessary for the House of Commons, as an institution, and its Members, as representatives of the electorate to fulfil their functions. It also refers to the powers possessed by the House to protect itself, its Members, and its procedures from undue interference, so that it can effectively carry out its principal functions which are to inquire, to debate and to legislate. In that sense parliamentary privilege can be viewed as special advantages which Parliament and its Members need to function unimpeded.'

House of Commons Procedure and Practice also informs us that '[T]he rights and immunities accorded to Members individually are generally categorized under the following headings: freedom of speech; freedom from arrest in civil actions; exemption from jury duty; exemption from attendance as a witness.'

The Chair finds that there is no apparent breach of privilege in this case. In his written notice the acting Leader of the Third Party made two points: first, that the Minister responsible for the Yukon Housing Corporation had ascribed false or unavowed motives to him and to another person. The attribution of false or unavowed motives is a Question of Order and not a Question of Privilege. As such the issue should have been raised at the time the words were uttered.

The acting Leader of the Third Party also expressed concerns about the Minister making comments about a person who is not a member of this Assembly and is not in a position to defend herself in this place. While the Chair may intervene to protect those who cannot protect themselves in this place, that is also a Question of Order – not a Question of Privilege – and the issue should be dealt with when the words are uttered.

During Committee of the Whole consideration of the estimates for the Department of Highways and Public Works, Mr. McRobb said certain government employees, in the absence of whistle-blower legislation, would – quote – 'put their jobs at risk by speaking out publicly under this Yukon Party Government' – unquote.

Mr. Cathers argued that Mr. McRobb had violated Standing Order 19(g) which says, 'A Member shall be called to order...if that Member imputes false or unavowed motives to another Member.' In responding to the Point of Order Mr. McRobb said Standing Order 19(g) applies only when one Member accused another. Procedurally this is not the case. A Member cannot escape the sanction of Standing Order 19(g) by attributing false or unavowed motives to more than one Member at the same time.

Though it is not a procedural issue, the Chair acknowledges that one reason some jurisdictions have adopted whistle-blower legislation is to protect workers whose jobs might be at risk if they spoke out publicly about alleged government wrong-doing. However, this is true of all governments as institutions. It is not only true of the current Government of Yukon.

The Chair finds that Standing Order 19(g) was not at issue last Thursday. Rather, the Chair finds that Mr. McRobb made a charge against the Government collectively. That is not in order. According to Beauchesne's Parliamentary Rules & Forms '(i)n any case where the propriety of a Member's actions is brought into question a specific charge must be made.' House of Commons Procedure and Practice adds 'a direct charge or accusation against a Member may be made only by way of a substantive motion for which notice is required.' In other words, such remarks cannot merely be injected in debate.

In order to ensure orderly debate the Chair would ask all Members to not make charges against one another.

We will now continue with Committee of the Whole consideration of Bill #3 and the Department of Environment."
